S. Dowds called the December 11, 2014 meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

#### **Departmental Reports**

The following monthly departmental reports were read and/or posted and filed in the Office of the Town Clerk: Town Clerk, Building Department, Assessor, Historian and Planning & Zoning.

#### **Board Review of Claims/Transfers/Amendments**

The Board reviewed claims #14-1842 to 14-1988 on Abstract No. 2014-12 which includes all funds and claims to be paid and those paid since the previous town board meeting.

#### **Briefing of Resolution Agenda**

The Board discussed resolution [2014-291]. Atty. Gruenberg said sometimes it is problematic to give benefits outside the normal process and asked if the union was in agreement with the terms of the proposed resolution. C. Curtis stated that the wingmen are non-union employees. Although C. Bult was not opposed to the benefit, he felt the Board should have a broader discussion as he was concerned that they might be setting a precedent. The Comptroller said the benefit has already been added to the last payroll, but she could void the checks and reissue new ones if the Board does not want to do it. She explained that there is a precedent and historically this has been done by adopting resolutions. Rather than do that, she felt it should be a policy and she has recommended that it be added to the handbook so it is memorialized. C. Bult said he was not aware it was past practice, but since it is, his earlier statement was a moot point. Board discussion ensued regarding what constitutes a major holiday per the CSEA agreement. The Board felt the resolution should be amended to include the year 2015. The Comptroller noted that if

they preferred, the reference to the CSEA agreement could be removed and just specify the major holidays of Christmas, Thanksgiving and New Year's Day. **Determination:** The Board was in agreement with the suggestions. The resolution will be amended to reflect the changes noted. With regard to resolution [2014-292], C. Curtis appreciated the work done by the Attorney and Supervisor regarding the disposal waste contract for the Transfer Station. Since the current contract expires at the end of the year, he realizes it is a matter of timeliness but wondered if any other options were considered. Further, he asked if the Town had the right to terminate the contract early, in the event a better option was found. S. Dowds said he looked at the City of Albany, but you have to join as a planning unit. With respect to an early termination penalty, A. Gruenberg said the prior contract with Colonie did not have one and he believed this 5-year contract was similar. The Board discussed some of the terms of the contract. Several Board members wondered if a penalty could be imposed if the Town did not meet the tonnage in the contract. A. Gruenberg said, that in the past, we did not meet the tonnage and no penalties have been levied against us. As A. Gruenberg reviewed the current contract he noted that there is not a penalty for not meeting the tonnage provision and he believed the new contract would have the same terms. Since the contract approval is contingent upon his approval, he assured the Board that he will review the provisions, especially regarding the items discussed. C. Swartz asked if [2014-279] was for review of the cooling tower for the Town Hall. S. Dowds said yes, but they will be looking at the entire heat/air conditioning system as well as the cooling tower. The proposal allows for a 50% reimbursement from NYSDERA. Further, the engineer will work with NYSERA and us for any grants that may be available.

### **Public Comment**

M. Sherwood asked if the funds being transferred into the special districts were from the districts or the general fund. The Comptroller said they were from each specific district. She explained that some of the districts accrued excess fund balance and it is a better fiscal practice to transfer the funds into a repair reserve fund. Then those funds could be used to pay for, or offset, any major repairs in the respective districts.

With regard to the Rules and Regulations for the Transfer Station, Bruce Goodall discussed the charge for televisions with the Board. He explained that he strips down the rear projection televisions, removing the plastic, particle board, etc., so the charge to the Town for disposal (.70/lb.) is less. That being said, he recently learned that in 2015 there will be a charge for all televisions - rear projections TVs will remain at .70/lb., and all others will be .28/lb. He said we will get charged by the pound and would need a scale to charge accordingly. As the discussion continued, the Board felt it would be better to eliminate the scale idea, and just set a flat fee. Since there were many different types, and varying weights for televisions, the Board tried to determine an equitable fee so the town doesn't take a loss, but is also fair to the residents. Mr. Goodall also noted that there was a typo for the dates for the spring clean-up days. They should be corrected to read May 14, 15 and 16<sup>th</sup>. **Determination:** The regulations will be charged to show the correct dates for the spring clean-up days and that there will be a \$14.00 fee for "regular" televisions and computers with monitors (CRTs) or 7 punches. This will take effect January 1, 2015. The Director was asked to advertise this in advance so people are made aware of the changes.

RULES AND REGULATIONS**

- 1) The Town of Schodack Transfer/Recycling Station is for use by Town residents only and is for disposal of refuse generated within the Town of Schodack. Proof of residency and vehicle registration must be provided in order to utilize facility.
- 2) Personal checks or money orders are the only means of payment accepted at the Transfer Station.

Brush will be accepted up to 30 minutes before closing each day.

3) The Schodack Transfer/Recycling Station area shall be open for disposal as follows:

Tuesday	7:00 a.m. - 5:00 p.m.
Wednesday	7:00 a.m. - 2:00 p.m.
Thursday	7:00 a.m. - 2:00 p.m.
Friday	7:00 a.m. - 2:00 p.m.
Saturday	7:00 a.m. - 3:00 p.m.

The Transfer Station is closed all day Sunday, Monday and Holidays as posted.

4) Residents will be required to pay for each 30-gallon bag, or portion thereof, of refuse disposed of as follows:

- 7) THE FOLLOWING RECYCLABLES WILL BE ACCEPTED AT NO ADDITIONAL CHARGE:
  - a) Newspapers/Magazines/Junk Mail – white paper. Books (hard & soft cover)  
Shredded paper (bagged)
  - b) Tin cans
  - c) Glass bottles/jars
  - d) Plastic bottles or containers (only recyclable codes 1 - 7)
  - e) Used oil and filters
  - f) Batteries - car and rechargeable
  - g) Anti-Freeze
  - h) Corrugated cardboard/Box Board/Brown

(hereinafter "Reserve Funds"). The purpose of the Reserve Funds is to accumulate moneys to pay for certain repairs to capital improvements or equipment. The type of repairs must not recur annually or a shorter intervals.

Except as otherwise provided by law, expenditures from the Reserve Funds shall be made only for the purpose for which the Reserve Funds are established. No expenditure shall be made from the Reserve Funds without a resolution of this governing board appropriating moneys subject to public hearing and at least five days must elapse between the publication of the notice of hearing and the date specified for the hearing.

In an emergency, moneys in a repair reserve fund may be expended without giving notice and without holding a public hearing. To make such an emergency expenditure, the governing board must pass a resolution approved by at least a two-thirds vote. In addition at least one-half of the expenditure must be repaid in the next fiscal year and the balance repaid by end of the fiscal year after that.

The chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The chief fiscal officer may invest the moneys in the Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Town of Schodack. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund.
