The Town does and shall maintain insurance coverage, presently with Travelers Insurance Company, in the sum of \$100,000.00, plus an additional \$100,000.00 for the Town Receiver of Taxes, the Town Supervisor, the Comptroller, the Deputy Receiver of Taxes, and the Supervisor's Secretary to indemnify against losses through the failure of the officers, clerks and

employees covered thereunder faithfully to perform their duties or to account properly for all monies or property received by virtue of their positions or employment, and through fraudulent or dishonest acts committed by the officers, clerks and employees covered thereunder.
