Supervisor Dowds called the January 5, 2016 Organizational Meeting to order at 7:02 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Briefing of Resolution Agenda

S. Dowds explained that the Organizational Meeting was a standard annual meeting, essentially consisting of appointments, salaries, and standardized necessary requirements. C. Bult initiated discussion on resolution [2016-011]. He said he had some concerns with the webmaster's request for a substantial increase for the 1st quarter and also the status of the new website. Dawne Kelly, who has been overseeing the project, responded to C. Bult's question about the new website. She explained that the web designer will be contacting her next week for direction on how we would like the site to appear. Then he will prepare a "mock" website for the staff to review and Board to review. She felt a realistic activation date for the new site would be no later than the end of February. C. Bult asked if the vendor would be able to do a demonstration for the Board at an upcoming meeting. S. Dowds said yes and asked Ms. Kelly to contact the vendor and request that they come to the January 21st Town Board meeting. With regard to the webmaster's salary increase, the Supervisor said Mr. Wheeler requested more money because he felt there was a lot more labor involved for the website in the beginning of the year. C. Bult said he read Mr. Wheeler's correspondence, but believed the requested amount was excessive. While he would like to be able to continue the relationship during the transition, he could not justify that amount of money. He suggested that they offer him the same rate that he had (\$2,000.00/guarterly). C. Kenney said part of his concern was that we are having issues with getting things posted on the website in a timely fashion, which occurred again last month, and he is requesting more money. Dawne Kelly said she is aware that there is still criticism about his timeliness and some, but not all, of the recent issues were his fault detailing the occurrences. It was C. Swartz's opinion, based on the information presented, that the salary for the webmaster should remain at \$2,000.00. S. Dowds polled the rest of the Board. They were all in

agreement that the resolution should be amended to reflect a salary of \$2,000.00. S. Dowds noted that without the requested increase, the webmaster may not continue and if so, we will essentially not have a current website. Board members were in agreement that they would take the risk.

S. Dowds noted that addendum 2016-05 for Laberge in resolution [2016-065] included a one-time charge of \$15,000.00 for MS-4 procedures. C. Swartz asked for further clarification regarding the MS-4 procedures. Ms. Fuda, Director of Planning & Zoning, explained that essentially, all procedures the Town takes for MS-4 compliance will be documented and detailed in a manual (i.e. – collecting data, cleaning out ditches, distribution of information, etc.). She said it is a DEC regulation that will be mandated by 2018. She explained that while we have some written procedures for the highway employees, they are not compiled in a manual that anyone can use. C. Swartz said since it is not mandatory until 2018, perhaps they should wait to see if there might be grant money available to do this later this year or next year. Ms. Fuda didn't believe that would happen. She felt they should do it now, as it will take about a year to compile the information and transform them into written procedures. C. Bult asked if DEC has to review it or do we just need to submit it. Ms. Fuda said it must be reviewed by DEC.

With regard to future reoccurring appointments for the boards (planning, zoning, etc.) C. Bult suggested that it would be helpful if the person in the position sends an email or note to the Board indicating their interest in continuing, rather than having the Board make that assumption. S. Dowds felt that was a good suggestion.

Public Comment

R. Lemka appreciated the fact that the Board was moving forward on having a more current website. He asked if Mr. Wheeler did agree to the salary, would he continue working after the new website is activated. S. Dowds said no. Commenting about the site where the proposed Project Red was supposed to be, Mr. Lemka said the Board should consider rezoning that area. It was his opinion that warehousing should be located on Route 9, not off Schodack Valley Rd. Mr. Lemka said he was disappointed with the Board's action regarding abandoning a "paper" street in Brookview Woods which was passed at the Close of Business meeting. It was his opinion that it was a political "deal". He felt the Planning Board put that street there for a reason and in the very least the Board should have requested their opinion before finalizing the action. He noted other "paper" streets in town that the Board has never acted on to abandon and wondered why this one was different.
