Supervisor Harris called the January 10, 2019 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Brief of Resolutions

S. Harris gave a brief overview of the resolutions. He noted the large bulk of the resolutions pertained to appointments and salaries for employees of the town. He stated resolution 2019-042 would be withdrawn at this time. With regard to resolution 2019-070, a change order was submitted by William J. Keller & Sons Construction Corp. for Sewer District 1, Extension 1 due to the discovery of a deeper rock bed than was originally anticipated. The Supervisor said even with the change order, the company is still under budget. For resolution 2019-073, the board would be granting Mr. Montross an extension for his leave of absence. This is due to his current job not allowing him to hold a badge under any other municipality.

Board Comment

Resolution 2019-069: C. Bult asked if the vehicle purchase was for a 2018 leftover. S. Harris said yes.

Resolution 2019-02: C. Bult asked why the time for the December 30th meeting was set for 6:00 p.m. D. Kelly said it had been changed to an earlier time many years ago. C. Swartz asked if it could be changed to 7:00 p.m. as it was more convenient. S. Harris agreed and recommended the time for the close of business meeting be amended. All board members agreed.

Public Comment

N. Fuda informed the board that the title "Building Inspector" was no longer recognized by New York State. She said resolutions 2019-015 and 2019-016 should be changed to include only Code Enforcement Officer. S. Harris said he would take the information under advisement.

M. Sherwood asked why some employees were paid hourly and some were salary. She gave the example of the two Deputy Town Clerk positions. P. Harter explained, under the new employee handbook, it was discovered that the town had been giving the wrong classification to the employees. The handbook states that all non-union employees who could accumulate compensatory time or be paid overtime should be in the class of non-exempt. In order to compensate appropriately, all employees in the non-exempt class must be hourly. He said they were in the process of making the conversion but it took time. With regard to resolution 2019-030, M. Sherwood said she was under the impression that after an employee had served for a given time and was on an eligible civil service list, they should be made permanent. She felt this should be done for the part-time police officers. C. Bult said he believed the officers were not on a list; therefore, they were truly part-time officers. M. Sherwood suggested the officers take the test as there would be added benefit to them for being on the civil service list. S. Harris said he would have counsel review the law to ensure we were following it properly.

K. Stokem said he was also confused regarding hourly versus salary employees. He noticed, by his math, the hourly rate seemed to be lower than the salary for a Deputy Town Clerk. P. Harter said the hourly pay, which was roughly \$34,000.00 per year, would be the rate for a new hire. He explained the salary for the Deputy Town Clerk was based on her being hired many years ago. Mr. Stokem asked if the Records Advisory Board had met within the last year (2019-035). S. Harris said no. Mr. Stokem asked if it was a functioning board. S. Harris said yes and explained that, even though the board may not have met, it was required by law. C. Swartz added the board was in place in the event it was ever needed. Mr. Stokem asked for a status update for filling the ethics board. S. Harris said they were working with counsel to update the ethics law. C. Rex said they expected to move forward to fill the board once the update was complete. Mr. Stokem noted additional funds were being allocated for town engineering for resolution 2019-065 even though \$180,000.00 had been allocated at the end of 2018. He asked if the board had considered creating a town engineer position instead of hiring an outside firm. C. Bult said the idea had been considered; however, it would be hard to find an individual who had the diversity of an entire firm. Mr. Stokem asked, even with the change order, if the company was under their bid for resolution 2019-070. S. Harris said they were under the contract amount. Mr. Stokem said he found it hard to believe as there seemed to be many change orders including a fence from last year. C. Swartz said they were over the amount for the bid that they had submitted. N. Fuda clarified that Keller was still under the amount anticipated to complete the contract as calculated by the engineer even though they were over their original bid amount. This was due to the under estimate of the depth for rock at that C. Rex said this was an issue that anyone submitting a bid would have location. encountered. C. Bult added that the geological survey did not disclose the actual depth of the rock which caused the company to under estimate their bid.

K. Stokem said he was known to be fiscally conservative; however, he felt that several employee salaries were too low compared to the amount of work they did. He felt the board should compare these salaries to those of other municipalities to make them more competitive. C. Bult said the board had made attempts to address the low salaries; however, due to the limits set by the two percent tax cap, they were forced to maintain the amounts and pick their increases based on given years. He said they had examined other municipalities as well. K. Stokem asked what percentage the salaries made up for the budget. P. Harter said around twenty percent. Mr. Stokem asked the board to consider adding more compensation in future years. He felt this would make the positions more enticing to future applicants when they become available. The board agreed to consider the salary increases in the future.

Departmental Reports: The following monthly departmental reports were read and/or posted and filed in the Office of the Town Clerk: Town Clerk, Building Department, and Historian.

Review of Abstracts of Claims and Budget Amendments: The Board reviewed claims #19-0001 to 19-0116 on Abstract No. 2019-01, in the amount of \$418,595.88, including the claims paid (\$41,664.54) since the previous town board meeting.
