Supervisor Harris called the June 13, 2019 Town Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Executive Session

C. Swartz made a motion at 7:01 p.m. to enter into an executive session of the town board to discuss two contracts, to consider an appointment for Dog Control Officer and potential litigation. Seconded by C. Rex.

Briefing of Resolution Agenda

S. Harris gave a brief review of the resolutions. For resolution 2019-183, he stated that Mark Geracitano would be named as the Dog Control Officer for the Town of Schodack. He noted an addition needed to be made for resolution 2019-186 to include Matthew Powers as a counselor for the Schodack Day Camp. With regard to resolution 2019-188, the Supervisor said Detective Thomas was currently using his personal cell phone for investigations and felt it would be best to have a town phone to protect his privacy. The Supervisor stated that resolution 2019-190 involved grants through NYS that the town may be eligible for. Resolution 2019-194 would set parameters in the event the solar farm was abandoned and needed to be overseen by the town. For resolutions 2019-199 and 2019-

200, P. Harter explained the claims were within normal standards and the budget modifications were in line with all current budgets.

Public Comment

Resolution 2019-196: Attorney Mark Flurry stated that he represented Mr. and Mrs. Hunt who felt that they were being singled out, by banning horses in the town park, as they are the only ones to ride there. He asked why this had become an issue and noted that they were certain to clean up after the animals. He advised that there was a constitutional requirement for any proposed legislation or resolution to have a rational basis. He had reviewed the rules and found none. He said Mrs. Hunt had spoken with the Supervisor and Park Manager who advised her to not pursue the matter and had threatened her. He explained there had been no issue with horses in the town park since it had been constructed in 2001 and added that they have allowed horses to be ridden in Central Park in New York City for over a hundred years. He felt it was unfair to deprive the Hunts the right to use the park and asked that a reasonable resolve be met. Mr. and Mrs. Hunt read a letter that was duly filed in the town clerk's office. They said that they felt they were being targeted and had attempted to address the issue with Mr. Garvansites, Park Manager. They explained that their horses wear manure bags, were not galloping around the fields and noted that they were experienced riders belonging to two pony clubs. They felt the issue should be addressed by coming to a middle ground instead of banning horses altogether. They suggested regulations be put in place such as staying on designated trails and avoiding the playground or pavilion. They added that there seemed to be limited regulation enforcement of the rules within the park, including dogs, such as the Police K9 being allowed off leash and garbage being left in the park. They said there had been incidents within the past year of dog bites in the park and felt that should be addressed. They said they were lifelong residents of the town and wished to have the park be kept as their little secret. D. Vullans of Sultan Lane said she had reviewed the rules and said there was nothing to limit them in the park. She said she was in support of the Hunts and asked why this was an issue. H. Finch of U.S. 20 said he was a previous horse owner and noted that he himself had been singled out by the town. He said he was in support of the Hunts as well and added that they purposely purchased their property to have the ability to ride their horses in the park. K. Stokem once again asked why the issue had arisen for horses in the park. S. Harris said concerns had been brought to their attention and as the park regulations had not been updated in a few years, the board felt that they needed to add the language regarding no dogs in the mulched area and no horses. Atty. Langlois said the change was proposed by the Parks & Recreation Department who has the right to propose regulations for the town park. C. Bult added that the board had purposefully chosen to have public comment before the board comment before they made their decision.

Summer Reading Program: M. C. Aitken, a trustee of the Castleton Library, wished to inform the board that they would soon begin their summer reading program for children and teens. This program is designed to improve reading skills as well as prevent the "summer-slide" that many children encounter during the summer break. She noted the program also includes an early literacy program which encourages parents to read to their children. She explained there was also an adult component that encourages adults to read books from new authors, different topics and even from different time periods. She added that besides

the summer reading program, the library also offered many goings-on such as arts and crafts, science based events of Dyken Pond, and various activities to encourage playing outside. They also bring in guests from Castleton Fire Department, the Schodack Police, News Channel Ten Weather and town board members. She mentioned that the library would be hosting an open house on June 26, 2019 to kick off the program with open registration and host a ribbon cutting for the newly renovated community room. S. Harris thanked her and asked that she have a condensed version to his office for posting on the town website. Mrs. Aitken said she would ask the director to do so.

Elmbrook Solar Farm: James Muscat II, Esq. of the Young/Sommer Law Firm said they had been before the planning board in October of 2018 regarding the Elmbrook Solar Farm to be located on Brookview Road. He said the sketch plan had been approved and the next step was to seek a zoning change for the location to PD-2 by the town board. Giovanni Maruca of Eden Renewables explained a community solar farm was to be constructed on the Brookview Road site. This solar array would inject energy into the power grid creating credits for energy that could be sold to community members at a discounted rate. He noted each member could see up to a ten percent decrease in their energy costs. The solar array would be located in a north to south orientation to track the sun and include battery storage. The energy would be delivered to National Grid mid-day when the need for energy is at its greatest. Once construction is complete, the site would be reseeded with native wildflowers and grasses to become a pollinator friendly environment. He added that the worm population would increase, making the land fertile for the expected twenty-five years of life for the array. To maintain the vegetation height, sheep will be grazed within the fence which will also aid in fertilizing the land. He said a total of four electrical poles will be added. It was the goal of the project to make the solar farm invisible from the road and added that residents had been consulted to minimize any issues or concerns. Atty. Muscat II asked the board to review their plans and asked that they consider the zoning change. C. Swartz asked what would happen after the twenty-five years of use. Mr. Maruca said the incentives would end and a decision would need to be made. They could either decommission the solar farm or repower the project. He said in the event that they choose to decommission, the clean-up would be fairly easy. He assured the board that most materials are recyclable including steel, copper, aluminum, and glass. There would be minimal concrete to support the transformer pad and it could easily be removed. S. Harris asked if the land would be returned to its natural form after decommission. Mr. Maruca said yes, it would be returned to farmland.

Sidewalks: M. Sherwood said she had noticed sidewalks being constructed in East Greenbush and had heard that they would continue into Schodack. S. Harris said he had heard of them coming to the edge of Schodack but not continuing into. He said it would be a good idea and would be a benefit to the town. M. Sherwood said a meeting had been conducted for residents in East Greenbush and asked if the discussion comes to Schodack, to also conduct a meeting here. S. Harris agreed.

Vacant Buildings: M. Sherwood said she had read an article in the newspaper regarding a proposed law for Rensselaer County to set aside funds for deteriorated properties. S. Harris said he had not read the article and asked if it was a law or grant from NYS. M.

Sherwood gave a copy of the article to the Supervisor. She noted that the law would define a property as vacant in a little as four to five months before they become deteriorated.

Planning Board: K. Stokem said he had concerns regarding how information from the planning board was posted on the website. He illustrated how the town board page included archived agendas, minutes and resolutions. He felt it was helpful to reference desired meetings to allow an individual to refer back to the appropriate meeting to view. He noted the planning board and zoning board of appeals pages only showed current agendas. He asked that both board maintain their pages in the same format as the town board. S. Harris said he would look into archiving the agendas.

Resolution 2019-190: K. Stokem asked what the grant was for. S. Harris said it was for home, community and urban renewal to assist the community.

Resolution 2019-191: K. Stokem asked if there was any progress in re-writing the section of law that dealt with landfills. C. Kenney said they were waiting for information from NYS DEC as their regulations were not clear. Atty. Langlois said he would contact the previous attorney. K. Stokem asked, when an application was received, if the town did their due diligence regarding the nature of the applicant. S. Harris asked if he was referring to a background check. If so, he said the application was reviewed, the site would be monitored and the town would confer with NYS DEC; however, no criminal history would be run on the applicant. C. Bult added that, after the engineering for the site was reviewed by Labarge, the application would be referred to the planning board before any action was taken. K. Stokem said he happened to know the individual who was applying and recommended that the board do a thorough check.

Board Comment

C. Bult recommended tabling resolution 2019-196 to allow the board to further discuss the matter and conduct research. All board members agreed to withdraw the resolution.
