Supervisor Harris called the September 12, 2019 Town Board Meeting to order at 7:03 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

#### Library Presentation

Library Directors Melissa Tacke (Castleton Library), Jill Dugas Hughes (East Greenbush Library) and Tracy Clague (Nassau Free Library) gave a combined presentation highlighting the services offered by each library to Schodack residents and an explanation for their 2020 budget requests. Ms. Tacke thanked the town board for their past financial support for all three libraries and was hopeful that they would view their dedication as proof for their funding requests. Ms. Dugas Hughes said whereas all three libraries are different, they do an excellent job of working together in a cost effective manner to serve the residents of Schodack. By supporting the libraries, the town is supplying branch structured library services to their residents. These services are offered to residents of all ages and provide services such as meeting areas for individuals and groups, use of computers and Wi-Fi, early literacy and senior reading programs, trust worthy sources and excellent customer service. Ms. Clague added that the residents benefit by the funding provided by the town. She noted they were in need of the support to help with their quality of service and said the three libraries were requesting a total of \$488,099.00 for 2020. The budget requests for 2020 for each library are as follows: \$146,786.00 (\$16,376.00 increase) for Castleton, \$311,313.00 (\$7,593.00 increase) for East Greenbush, and \$30,000.00 for Nassau. Ms. Tacke said they were requesting such a sizable increase in funding for Castleton to allow for a more reasonable salary for staff, increase their electronic and print collections and to upgrade equipment. Ms. Dugas Hughes added that their request is a 2.5% increase from the funding in 2019 for East Greenbush which will be used to pay off their last bond payment.

Several services that are offered to residents were highlighted during the presentation including the removal of overdue fees for books or materials not returned to the library (Castleton), an increase in the number of museum passes that are offered (Castleton, East Greenbush and Nassau), monthly book mobiles (Castleton), red cross babysitter certification program (Nassau) and Friday Nights at the library for teens (East Greenbush).

#### Briefing of the Resolution Agenda Discussion-Resolutions

S. Harris gave a brief overview of all resolutions. With regard to resolution 2019-225, he noted a question had arisen at the previous meeting regarding Ms. Justus' qualifications. He said some of the missing courses had been completed and added that it was difficult when all were offered during different times of the year. He stated she was still missing a few classes but still had time to complete them. It was his recommendation to follow through with her reappointment. For resolution 2019-236, the Supervisor explained that a transformer had exploded on Beaver Road off of Route 20 which was believed to have damaged the backup generator at the Sewer District #2 substation. To ensure that there was no interruption in power to the station until the other can be replaced. The cost will be passed onto the town's insurance company for reimbursement. All other resolutions were self-explanatory.

#### Board Discussion: None.

**Departmental Reports:** The following monthly departmental reports were read and/or posted and filed in the Office of the Town Clerk: Historian, Town Clerk and Building Department.

**Review of Abstracts of Claims and Budget Amendments:** The Board reviewed claims #19-1348 to #19-1525 on Abstract No. 2019-09 in the amount of \$576,285.56, including the claims paid prior (\$333,241.02).

#### Public Comment – Resolutions

**Resolution 2019-224:** K. Stokem asked what caused the "not to exceed amount" to be increased. Atty. Langlois said the amount to have Girvin and Ferlazzo defend the Planning Board against the Article 78 had been estimated prior to motion practices which caused the \$12,500.00 to be exceeded. It was recommended that the amount be increased to \$20,000.00; however, he did not believe they would reach that amount. K. Stokem asked if the amount for legal fees was all inclusive. Atty. Langlois said the amount would go for appeal only. It would not cover any fees if the suit went to the Supreme Court. K. Stokem asked Mr. Stokem to contact his office. M. Brunner said she had calculated the total cost to date as \$41,000.00. She noted that had the full Environmental Impact Statement (EIS) been completed, this all could have been avoided.

Resolution 2019-225: K. Stokem asked what the term of office is for the Assessor. S.

Harris said six years. K. Justus added that she started in June of 2017 to finish out Peter Goold's term. This would begin her first full term.

**Resolution 2019-230:** K. Stokem asked what the normal rate is for a refrigerator or tires to be dropped off at the Transfer Station. B. Goodall said \$12.00 and \$4.00 respectively.

**Resolution 2019-237:** K. Stokem asked if this resolution only authorized letters to be sent. Atty. Langlois said yes.

**Resolution 2019-238:** K .Stokem asked why a letter of credit was necessary for Strawberry Fields. Atty. Langlois said this is standard practice to create a fund for large projects in the event issues arise and the town needs to repair damages. He noted the developer was adding road for the new section of the cul-de-sac. S. Harris said the funds could also be used for drainage. K. Stokem asked how the amount was calculated. Atty. Langlois said the Town Attorney figured the amount based on the project size.

**Resolution 2019-251:** K. Stokem asked if Sewer District #7 was for the Schodack Central School District. P. Harter said the old Hamilton Printing, which is now Hudson River Foods, is the only user for Sewer District #7.

#### Public Comment

J. Williams expressed her concern for the scheduled blasting at the Amazon site. She felt there should have been more oversight by the Town Board, Planning Board and Blasting Company regarding regulations. She noted a resident had been notified of the blast and alerted a town official to the potential issues. She was appalled that it took a call from a resident to get the town to take notice of county laws. She asked what precautions, including weekly meetings, were in place if the blasting was to occur. She wanted to ensure that all town, county and state codes were being followed, that all residents were aware of activities and were notified in a timely manner. She noted that Local Law #2, section 4A of the Rensselaer County Code stated that notification must be sent by certified mail forty-five days in advance or prior to a pre-blast meeting to all residents within one mile radius of the site and pre-blast water samples must be taken from all wells of those affected. She said a request was made by residents to hold a meeting at a more convenient time so they can be informed and have their concerns heard. She asked the board to do their best to rectify the situation and in the event any damage is caused by the blast, that those residents are compensated appropriately. Atty. Langlois assured Ms. Williams that he was acting as a liaison to keep the lines of communication open between the Planning and Town Board. She asked if Atty. Langlois was well versed in County Code. He admitted he was not versed in all law; however, an email had been sent to Scannell and Maine Drilling to ensure that the issue is addressed and a pre-blast meeting had been scheduled. Ms. Williams recommended an expert be hired who was familiar with this portion of code as there were still too many questions left unanswered.

M. Brunner said without an EIS, the residents have experienced issues such as flooding and dust. She stated that some residents had received a letter on September 9<sup>th</sup> regarding blasting which was scheduled for September 12<sup>th</sup> but it wasn't until after an email had been sent to N. Fuda regarding town code that all others were notified. She noted that she had asked on several occasions when Ms. Fuda would be attending a meeting to give a progress report for the updating of the town zoning laws and said this still had not taken place. She scolded the Supervisor and a Town Board member for previous positions taken by them during prior elections.

A resident of Route 9 said she lived within 250 feet of the blasting site and was concerned that a thorough pre-blast survey had not been conducted. She added that another resident was concerned about a crack in their foundation which may get worse after the blast. She also said the original plans included National Grid bringing natural gas lines to the site from the north but have decided to run them from the south which would cut across her property.

K .Stokem said he was concerned that other large projects would be coming into Schodack and with the potential for other litigation, he asked that full EIS be conducted. He mentioned that the Town Board could be named as lead agency for these projects to ensure that this is done. He noted that the Planning Board rarely, if ever, requires a full EIS. He said he felt that the Planning and Town Board were working against the residents of the town and not in their best interest. He added that when the comprehensive plan was established, an evaluation was to be conducted every five years which has yet to be done.

R. Giordano said if the Planning Board had followed their guidelines from 1994 when they added light commercial for the Route 9 corridor, a proposed sales distribution center would have been looked at properly. He added that he was concerned about the speed limit on Route 9 which changes from 45 mph to 55 mph just before Richwood Drive. He said cars were going too fast and with the added traffic that the Amazon project will bring, there should be a decrease to 45 mph for the entire stretch.

R. Jansing stated that the noise from the Amazon site was continuing to disrupt him and any guests that he has tried to entertain. He said he had contacted Ms. Fuda who advised him to close his windows during hours of operation and she stated that the project would be completed in November of 2020. He said he was also concerned about the blasting. He explained the residents had only been notified on September 4<sup>th</sup> and asked who in the town knew about it.

A. Cash said trucks are constantly parking illegally on the side of Route 9 and block Kingman and Woodward Road. She said nothing is ever done to stop them and was concerned that the trucks from Amazon would do the same. She felt the project was not being overseen properly and recommended hiring professionals to ensure that it was. She added that Ms. Fuda's attitude needed to be addressed.

M. Sherwood said she has been coming to the meetings for many years and missed having Ray Lemka as the voice of reason. She asked who enforces the regulations set by Rensselaer County.

A resident asked how they would be notified if the pre-blast meeting was cancelled. Atty. Langlois said a notice would be posted on the town website, town Facebook page and at the town hall.

A representative from TJA said he had been told to be at the meeting for his presentation on the proposed solar farm. He asked the board if they would like him to present tonight or wait until the public hearing. It was the consensus of the board to have him present on October 10, 2019 at the public hearing.

#### Executive Session

C. Swartz made a motion at 8:46 p.m. to enter into an Executive Session of the board to discuss matters pertaining to contract negotiations. Seconded by C. Bult.
