Public Comment

Stable Gate Winery: H. Sperazza of 2337 Payne Road read a letter expressing his dissatisfaction in the noise, including music and fireworks, emanating from Stable Gate Winery. He said he had contacted the police and was appalled to hear that the ordinance for Schodack states that noise fewer than ninety decibels can occur until midnight. He noted that the officers were sympathetic to his situation but were unable to do more than ask the owner of the venue to turn the music down. As for the fireworks, he said other neighbors reported their animals being frightened along with health issues due to the shock. He asked if the disruption was worth the \$100.00 revenue the town received for the fireworks permit. He felt the area, which is primarily agricultural, was not suited for this type of venue and asked the board to make a change to the town code regarding the noise ordinance. A copy of Mr. Sperazza's letter was duly filed in the office of the Town Clerk.

Swartz, T. Rex, D. Harris. Noes – 0.

- T. Kirby of Reno Road said he resided approximately five hundred feet from the winery and unlike Mr. Sperazza, he felt the fireworks and music were not very noticeable. He said the owners of the property had done a nice job of restoring the barn and considered them to be good neighbors. It was his recommendation for the neighbors within close proximity to the winery to open the lines of communication and work any issues out amongst themselves rather than allow one individual to dictate changes that would affect the whole town.
- K. Rapant of Brook Pointe Senior Housing said it was customary for most residents to be to bed by 8:00 p.m. and the sound of fireworks, which was similar to heavy artillery, was very disruptive to their quality of life.
- S. Feldman, owner of Stable Gate Farm, thanked Mr. Kirby for his kind words and said he

was not aware of any issues until there was a disruption at one of their events as well as being made aware that Mr. Sperazza was petitioning for residents to attend the meeting this evening to protest his establishment. He explained, following meeting with Mr. Sperazza, he had downloaded a decibel meter on his phone and took measurements to understand the extent of the noise. He noted the readings were found to be 82 within the building, in the sixties by the mailbox and in the forties on Mr. Sperazza's property. He said it was not his goal to disturb the peace and was willing to make changes to satisfy the neighbors. He explained that sound absorbing material had been installed in the barn, the music was redirected away from the neighbors, neighbors were notified of an event upon request and, with the exception of one event next year, he will no longer offer fireworks at that location. He noted that the Meadows had been an event center since the 1930's and that he wished to remain a good neighbor.

- J. Hughes of Poyneer Road said he had received prior notice from Mr. Feldman regarding the fireworks over the summer; however, the second to last time, he did not causing his horses to panic. He had expressed his concern to the town who agreed to contact him when a permit was issued for the facility. He stated that he had no issue with the fireworks so long as he was notified and said for the last event, he received notification by the town as well as Mr. Feldman.
- H. Sperazza asked if other complaints regarding the noise from the Winery had been received by the town. S. Harris said a few. Mr. Sperazza said he had spoken to C. Kenney regarding his concerns who informed him that changes were coming. C. Kenney stated that when they spoke, he asked Mr. Sperazza to remain calm and they would work it out. Atty. Langlois said he was informed of the issue a few months back and where both positions were legitimate, he felt it was best to open the line of communication to find a way to resolve. Mr. Sperazza said it was the responsibility of the town to intervene and noted that he and others wanted to be involved in any meetings for changes to the noise ordinance. C. Kenney said any changes to the town code should be based on the needs of the town and not due to one business. The board had asked Atty. Langlois to look at the code of other towns and said both parties would be included in the conversation. Mr. Sperazza noted that other local municipalities had noise ordinances with decibel levels far less than ninety and asked the board to consider mimicking those.
- A. Fonda of Reno Road said he had lived near the venue for two years and had been contacted by Mr. Feldman on many occasions forewarning him of any fireworks. He mentioned that he had visited the winery and said the town ordinance was established for a reason. He felt if a review was needed, it should not be based on one business.

A resident of Linda Way said she could hear the music from Music in the Park much louder than she could from the weddings up the street.

F. Rapant of Poyneer Road said where the music from the venue has no affect on his family, the fireworks are disturbing to his family and pets. He felt a review of the town code regarding noise couldn't hurt, especially with the variation between the town ordinance and other neighboring towns.

J. Dolan of Reno Road said Stable Gate Winery was a good neighbor and appreciated that Mr. Feldman was taking measures to address issues such as eliminating the fireworks as they unnerved him a bit.

Castleton Library: Mary Claire Aitken, a trustee of the Castleton Library, thanked the board for their continued support of the library and gave an update on the outreach services they offer. She explained that not everyone is able to visit the library which is the reason for their book mobile that makes regular trips to Riverside Nursing Home and Castle Hill senior housing. The mobile, which is run by the director using her own vehicle, provides bins of books and movies as well as items requested to over fifteen seniors. Youth services are also offered through visits to Castleton Kids for story time and crafts, quarterly visits to preschools, language labs for enrichment and monthly book clubs. To help promote the library and spread awareness, activity tables are set up at local events such as the Castleton Farmers Market. S. Harris said he considered Castleton to be the finest small library in the capital district and added that if they had any events that needed promoting, they were welcome to have them posted on the town website.

Stewarts: J. Dolan recommended that since the proposed location for Stewarts is in close proximity to neighbors, a stipulation should be put on them to turn lights off at night as to not disturb anyone. He also felt that the board should require Stewarts to conduct environmental reviews of their two prior locations to see the impact a gas station has had.

Noise Ordinance

Atty. Langlois said he was made aware by the board of an issue with the noise ordinance and looked into options to address the issue. He noted that an amendment could be made, by local law, to the code but cautioned the board against micromanaging. He said the original code was adopted in 1994 for the current noise ordinance of midnight to 6:00 a.m. From his research, no prior concerns had been reported and whereas the board could choose to review the code, they must look at whether this is indeed a town-wide issue. With regard to Stable Gate Winery, a provision was put in the code to protect agricultural land and keep it free from restriction. In the event a change is made to the code, the board must ensure that it will not violate the rights of the winery.

Board Comment

C. Bult asked for an update with regard to ongoing contract negotiations. Atty. Langlois said, if the board would entertain a motion to go into an executive session, he would be happy to give an update on the progress.

Executive Session

C. Swartz made a motion at 8:16 p.m. to enter into an executive session of the Town Board for the purpose of contract negotiations. Seconded by C. Kenney.

5 Ayes 0 Noes. MOTION CARRIED. Ayes – J. Bult, M. Kenney, S. Swartz, T. Rex, D. Harris. Noes – 0.

- S. Harris noted that no further business would follow the executive session.
- C. Bult made a motion at 8:36 p.m. to adjourn the executive session. Seconded by C. Rex. 5 Ayes 0 Noes. **MOTION CARRIED.** Ayes J. Bult, M. Kenney, S. Swartz, T. Rex, D. Harris. Noes 0.
