Supervisor Dowds called the February 11, 2016 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Kinder-Morgan

The Supervisor announced that they were deviating from the established format of the meeting to receive comment on the proposed Kinder-Morgan (N.E.D. aka Tennessee Gas) Pipeline and resolution [2016-102].

Before opening it up for public comment, S. Dowds gave a brief chronological update on the town's involvement. After learning about the proposed pipeline in 2015, the Board attended the scoping sessions held by Kinder Morgan. In May of 2015 the Town Board adopted a resolution opposing the pipeline. They also joined with a group from Massachusetts called the Berkshire Regional Planning Commission ("Berkshire Group"), which consists of 15 - 17 municipalities and that Commission subsequently engaged the services of the BCK law firm to represent their position of opposition. BCK specializes in pipeline activities and they worked with the municipalities to prepare the "scoping" comments. A document was submitted to the Federal Energy Regulatory Commission (FERC) in October and included concerns, general and specific, from all the members of the coalition. We then filed for Intervenor status, as an individual town as well as part of the coalition. That simply means we are allowed to present objections to FERC in legal format. Rensselaer County initially paid \$25,000.00 to represent the county and towns of Stephentown, Schodack and Nassau in the Berkshire Group. Now, we are at the point that we have to contribute to the costs of legal representation as an Intervenor which could range from \$20,000 - \$40,000 per municipality; however, it is something the Board feels they need to do to continue to fight for the residents of Schodack. FERC is currently in the process of analyzing the Environmental Impact Statement (EIS). When that is completed, then Kinder Morgan will know if their project is approved and what route is chosen. Currently, there are different rumors around town regarding the proposed route and location of the compressor station, but there is nothing concrete at this time. The Supervisor

continued that while some people may have been contacted about the potential sale of their property to cite a compressor station, to the best of his knowledge, nothing is definitive. He contacted the Berkshire Group when he first heard the rumors and they wrote to FERC about these concerns. FERC's response was, "if they (Kinder Morgan) make changes, they will have to file it formally on the docket. In addition, they would have to abide by the public notification requirements under 18CFR157.6D. In a compressor station's case they would have to notify all landowners within $\frac{1}{2}$ mile of the new proposed station site." The Supervisor said none of that has been done at this point. The Board is on record of being opposed to the pipeline. They have adopted a resolution voicing their concerns and plan to adopt another one tonight; however, if it does happen, we need to be prepared. He said the Board's job is to protect to the extent that we can, the residents of the Town of Schodack and that is exactly what we are trying to do.

Public Comment

The meeting room was filled to capacity and fourteen people offered comment on the pipeline. All who spoke supported the Board's resolution and many made suggestions to strengthen its language. They also felt the Board should do more to get information about the pipeline out to the general public because many people still are not aware of this potential project. Specific comments are as follows:

K. Stokem, Maple Hill Rd., thanked the Board for the initiative they have taken, but hoped they would take a more communicative stance in the future. He said the groups working as a coalition against the pipeline are calling on the Governor to put a moratorium on gas pipelines until a health study has been done, which he said was requested by the American Medical Association and New York State Medical Society. They are also asking the Governor to deny any approvals of permitting that is required by New York State for any gas pipelines. He requested that the Board add similar language to their resolution and be more demanding.

R. Lemka, Phillips Rd., agreed. He felt the resolution should be more demanding and definite as to what Schodack fears and, in his opinion, will experience, such as the potential damage to the aquifer and negative impact on the town's tax base by lowering property values.

M. Sherwood, Sally K. Lane, agreed and felt the potential damage to the aquifer should be fully and completely expressed.

D. Spilman, Mountain View Rd., also agreed. He said he attended a meeting about the operation of compressor stations and during routine maintenance to clean the lines, the contaminants are essentially dumped at the site and there is very little oversite. So, in his opinion, it is not a matter of if the aquifer would be damaged, but how quickly it would happen. He told the Board that under the Coastal Zone Management Act, the Department of State has to sign off on the pipeline. In addition to the Dept. of State, any municipalities that have developed a plan for coastal planning have a right to have input. Since the Town of Schodack and the Village of Castleton did adopt a plan in the early 1990's, they have standing in that process. He stated that FERC has to submit to request input from the Department of State (DOS) at least 90 days prior to their final approval. They can deny it and pointed out several instances where the DOS and/or Governor denied similar type actions. So far they have not done and have until April to act. Things can still be done so he requested that the Town partner with the Village of Castleton and form a Board that could communicate their concerns to the Department of State.

L. Cookson, Town of East Greenbush, said residents of East Greenbush are also fearful that gas leaks could be catastrophic and noted that the Town of East Greenbush is also proposing to adopt a resolution in opposition to the pipeline.

S. Bennett, Burden Lake Rd., made a correction to comments made by previous speakers relating to asking DEC and the Governor to put a moratorium on air and water quality permits. She said she had a meeting last week with Sen. Breslin who requested that same thing and Sen. Breslin was advised that DEC has a finite period of time to either approve or deny a permit, if that decision is not made within the required time frame, the State's approval or denial becomes inconsequential, so asking for a moratorium does not stop the clock. She suggested that if the Board was going to add language to the resolution they should ask the Governor to deny air and water quality permits by the allotted time frame; otherwise, the state will have no power.

R. Malloy, Maple Hill Rd., who was new to this issue, said it was his understanding that the ability to stop the pipeline is above this level of government and suggested that the citizens regroup and contact federal agencies.

J. Jensis, Jensis Rd., said he has a natural gas metering station on his road and they get a lot of gas odors. He wondered if communities should consider funding air quality at metering stations or at the compressor station in Malden Bridge.

Nancy Posniakis, County Route 7, said she was grateful for all the efforts being made. She said she has a pre-existing health condition and feels that she and others like her may not survive the toxins released by the pipeline.

S. Catlett, Shufelt Rd., said one of the alternate sites for the compressor station is off Shufelt Rd. and it is ruining her life. She asked the Board to be her advocate in fighting this huge corporation.

T. Costo, Shufelt Rd., said he is an engineer. He believes that most, if not all of the alternative sites for the compressor station in Schodack, are over the aquifer. Using the recent issue in Hoosick Falls relative to water quality as an analogy, he said the chemical that polluted their water supply was not originally perceived as a concern. Similarly, some of the things used by Kinder Morgan today may appear to be safe but perhaps in 25 years we will find that they are not, by which time, they will be in the ground, the water and the air and there will not be any easy way to remove them. So he encouraged the board to use whatever ability they have to protect, in particular, the aquifer and to consider within the resolution bringing particular attention to the circumstances in Hoosick Falls.

M. Joselyn, Maple Hill Rd., said fracking is illegal in NYS and wondered why fracked gas is allowed to be transported through the state. She asked the Board to do more with regard to getting information out to the public.

S. Sober, Shufelt Rd., said she is a member of the organization called STOP NY Fracked Gas and has been attending meetings for over a year. They did a huge informational mailing last year and may be doing another one. They are on social media and have done door-to-door. There has been widely publicized public meetings about the pipeline and articles in the newspaper and wondered what more could be done to get the word out.

S. Roth, Tina Lane, asked if the Board members had a personal position on the pipeline. S. Dowds said he was opposed to the pipeline. Mr. Roth said his impression from hearing the residents speak was that they feel they need to convince the Board to oppose the line and asked Board members if they would mind stating their position on the pipeline. C. Bult said he was against it. He has attended numerous meetings on the issue with the

STOP NY Fracked Gas group and will continue to do so. He believes the Board needs to be as aggressive as they can in opposing this, within the scope of their authority. C. Bult said he thought that there was a lot of frustration because the people feel that there is not a lot they can do to control this. Having a forum like this allows people to share their thoughts with the Board. While there may not be a lot the Board can do, we are one step higher on the chain than the average citizen. C. Kenny agreed and stated that he is 100% against the pipeline. C. Swartz said he is also against the pipeline as well as siting the compressor station in the town. He stated that he stands with everybody in the fight against the pipeline project. C. Rex stated that she is also against the compressor station and pipeline going through Schodack. The Supervisor said after FERC analyzes the EIS there will be additional meetings held to get public comment. He felt that was the best forum for the people to share their concerns.

K. Stokem said that most of the people feel that FERC is an entity that was set up to facilitate pipelines, not to slow them down, so it is hard for them to look to FERC for help, which is why they (the stop the pipeline groups) are advocating reaching out to higher level people (federal senators, Governor, etc.) and agencies. Their hope is to defeat the pipeline by "death with a thousand cuts", which means that hopefully each community can make a cut in it and slow it down. If it costs Kinder Morgan more money to fight them, we hope that they will give up on the pipeline.

B. Hastings, Pine Drive So., said Kinder Morgan stock has fallen recently and they cut their dividends.

B. Dooley, Schodack Valley Rd., felt that nothing was more important than fighting the pipeline and any money spent is a good investment.

J. Wilson, Middlesex Rd., thought they should stress how dangerous the pipeline could be due to the explosive nature of the gas.

F. Curtis, Boyce Rd., said the originally proposed compressor station is 1500' from his daughter's home on Clarks Chapel Rd. He said because so many groups and municipalities were voicing their opposition, it got the attention of federal officials. Sen. Schumer and Congressional leaders Gibson and Gillibrand wrote letters to FERC requesting that alternate sites be reviewed, so he felt voicing your concerns does make a difference. Unfortunately, of the alternate sites selected, seven of them are within a 1 mile radius of his house. There is another in the Town of Nassau by the intersection of Rte. 43 & Rte. 66 and two others on Rte. 9 in Schodack by Shufelt Rd. Mr. Curtis asked if the Board could advise the people about the potential sites for the compressor station. S. Dowds noted that in December FERC requested that Kinder Morgan submit alternate sites for the compressor stations as well as other viable routes.

The Supervisor thanked everyone for their comments.

Time Warner Agreement – K. Stokem said he is not happy with his Time Warner service and asked the Board if there was anything that could be done to get them to provide better services. The Supervisor explained that that we haven't renegotiated our agreement because we would lose some of what we currently have under the old agreement. For example, currently, we have an agreement to extend services if there are 20 properties within a linear mile. Their standard is now 35 properties. He has spoken with the Public Service Commission and they essentially advised him that we were better off not signing a new agreement. He clarified that the resolution on the agenda has nothing to do with the agreement, but essentially recites the convoluted mechanism we have to use regarding their payment of taxes. Time Warner pays the town a franchise fee to operate its business in the public Right-of-Way (ROW) and it would be simple for us to simply deduct the taxes from the franchise fee, but we are not allowed by law to do that. We have to levy the tax and then send the county a check for the taxes. We are precluded from simply deducting the tax levy from the franchise fee. C. Swartz said he talked to a representative from Time Warner recently and he was told that southern Rensselaer County may be getting an additional 1.9 million lines within the next year and a half.

Zoning - B. Dooley asked about the status of the zoning revisions, especially the definitions. He felt that some of the definitions in the zoning code were somewhat ambiguous and questioned that it sometimes seemed intentional. S. Dowds said they are currently working on it.

Town Center - T. Kirby encouraged the Town Board to support the move towards the Town Center concept. Phase I of the Town Center Project went extremely well and he strongly encouraged the Board to support Phase II of the Town Center Project. He felt that the Town doesn't really have a Comprehensive Plan. He said it is more a bunch of concepts and he thinks that the Board needs to make it into a Plan which would be more meaningful. He felt that if they want to increase tax revenues and services to the Town, the town center would provide that mechanism. The Supervisor explained that there is a resolution on the agenda tonight relative to appointing some people to the CDTC study for the Town Center Project. He felt they need to think of what can be done in terms of mixed use. Phase II, which is grant funded, is to review zoning issues that need to be addressed so that landowners and developers know what to expect from the Town, because they are the ones that will make it happen.

S. Roth said he was encouraged to hear about the development of a town center. He said there were many different master plan studies and to the best of his knowledge, none were ever adopted. He felt a Master Plan was essential for the development of the town. He also felt that the town has scared business away. The Supervisor replied that we do have a Comprehensive Plan. He agreed that the Town has the reputation of not being business friendly, but that is in the past. The Town is trying desperately to attract businesses because the only way to stabilize, and potentially lower, taxes is through economic development and we are doing the best we can to work towards that goal.

<u>Recess</u> – The Board recessed at 8:25 p.m. and reconvened at 8:37 p.m.

Resolutions: Based on comments offered, the Board revisited resolution [2016-102]. After a brief discussion, it was the consensus of the Board to include language regarding protection of the aguifer and to urge the Governor and key state agencies to deny air and water quality permits under the Clean Water Act. Determination: The resolution will be amended to include the following language, "WHEREAS, the proposed pipeline will cause significant damage to the Schodack Aquifer and thus to the quality and quantity of water for town residents; and BE IT FURTHER RESOLVED that the Schodack Town Board specifically requests that Governor Cuomo, the Department of Environmental Conservation, the Department of State, and all other agencies that have authority to make decisions relating to the pipeline oppose the pipeline in the Federal Energy Regulatory Commission (FERC) proceeding and further deny any permits under the Clean Water Act; and"; further the resolution will also be sent to the Secretary of State and Commissioner for the Department of Environmental Conservation. C. Rex requested that the next time a resolution is going to be drawn up and copied to the Board she would like to be included. C. Bult asked if the Building Inspector had inspected the trailers (resolution [2016-99]). The Town Clerk said yes. They are not forwarded to the Board, until he has given his approval.

Fire District Consolidation: S. Dowds said he heard a rumor that they were looking for a another lane on the southbound ramp coming off Exit 12 and possibly a traffic device due to the heavy volume exiting off that ramp at night. He cautioned that it was only a rumor and he has not received any official notification.
