Supervisor Dowds called the November 5, 2015 meeting to order at 7:08 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Public Hearings-Capital Assessment Rolls & Operation and Maintenance Rates for Water Districts

At 7:10 p.m., the Supervisor called the public hearings to order for the water districts. The Town Clerk read the Affidavit of Publication regarding the public hearings for the capital assessment rolls for Water District No. 1 - Clearview; Water District 2a - Inglewood, Water District 3 - Maplecrest; Water District 5 - Exit 10/Miller Rd.; Water District 8 - Schodack Center; Water District 9 - Route 20 area and Consolidated Water District 101 which were noticed in the 10/20/2015 edition of the Record and posted on the Town Clerk's signboard on 10/20/2015. The Operation and Maintenance hearings were held at the same time for water districts Water District No. 1 - Clearview; Water District 3 - Maplecrest and Consolidated Water District 101 and were noticed as indicated above. As the notices for the water district public hearings were similar, the only notice read was for Water District No. 1.

The Assistant Comptroller, Laura Palmer, led the public hearings for the water hearings. She stated that she was going to deviate from the normal sequential hearing process and group the districts by category. With respect to Operation and Maintenance Rates (O & M) she stated that no rate changes were recommended.

She explained that the Capital rates are driven by the EDU methodology, which remains the same as last year (see October 8th minutes), and the debt service (amount owed for the capital project). Even though the EDU methodology did not change, annual changes in the number of EDUs, based on changes in properties and water consumption of commercial users occurred. Also the amount levied fluctuates annually, based on the debt service schedules, reserves or other amounts applied to offset the levy. See following slide.

Water Districts

NO changes to O&M District Rates.

Capital rates:

- EDU methodology unchanged from previous year.
 However, annually there are changes in the
 number of EDUs based on changes in properties
 and changes in water consumption of commercial
 users.
- The amount levied changes annually based on the debt service schedules and any reserves or other amounts applied to offset the levy.

November 5, 2015 Water & Sower Public Hearings Presentation

With respect to the sale of water, she explained that it pertains to:

- 1) Commercial Water Sales this remains at \$.01/gallon
- 2) Sale of water from Clearview to Maplecrest (SW3) the 2015 rate of \$2.40/1000 gals. will increase to #2.75/1000 gals. for 2016. There is a cost associated with providing water from the Clearview supply to Maplecrest. They calculated that Maplecrest uses 22% of the water so therefore they should pay 22% of the cost; however, this increase will not affect the Maplecrest O & M rates.
- 3) Sale of water from Consolidated Water District 101. This is called the EW supply and that will remain at \$2.75/1000 gals.

Public Comment

K. Stokem asked why the rate was so low for commercial water sales. Ms. Palmer said when you compare that cost to what district residents are charged for overage, which is \$4.00/1000 gals., it is 2 ½ times greater than that, equating to \$10.00/1000 gals. When you consider those factors, it is not as inexpensive as it appears. Also, it is important to remain competitive or commercial users will go elsewhere.

Clearview, Water District #1

The public hearing for the Capital Assessment Rolls and Operation and Maintenance costs for Water District #1, Clearview, opened at 7:17 p.m.

Operation and Maintenance/Capital Roll – This district has 167 users. With regard to the O & M, the current rate is \$50.00/quarterly for the 1st 18,000 gallons with an overage charge of \$4.00 per 1,000 gallons in excess of the 1st 18,000 gallons. No changes were recommended for this district. This district has a healthy fund balance which aids them in keeping the rate flat. With respect to the Capital Roll there are 244.00 capital units which is an increase of 2 units from 2015. There are no reserves left from the project that was done in 2009 so the capital rate will increase by \$26.83 or 23% for a unit rate (EDU) of \$142.01. This rate should stabilize and remain at, or around that level, barring no further capital expenditures.

Public Comment – None

As there was no public comment, the Supervisor closed the public hearing at 7:19 p.m.

Maplecrest/Water District #3

The public hearing for the Capital Assessment Rolls and Operation and Maintenance costs for Water District #3, Maplecrest, opened at 7:19 p.m.

Operation and Maintenance/Capital Roll - The current rate is \$85.00/quarterly for the 1st 18,000 gallons with an overage charge of \$4.00 per 1,000 gallons in excess of that and will remain the same for 2016. In terms of the Capital Roll, there is a 36% increase. This is because the excess capital funds from the project that were being applied to the debt service have been depleted. This district has a total of 44.5 units (same as 2015). The rate will increase by \$196.65 for a total of \$566.81/EDU for 2016.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:22 p.m.

Consolidated Water District #101, et.al/Enterprise Town-Wide Water Supply

The public hearings for the Capital Assessment Rolls and Operation and Maintenance costs for the Enterprise Town-Wide Water Supply Fund, Consolidated Water District #101, Water District 2a, Water District 2b, Water District 4, Water District 5, Water District 8 and Water District 9 opened at 7:22 p.m. Ms. Palmer said most of the districts increases were due to the loss of units and having exhausted their individual fund reserves.

Operation & Maintenance – The current rate is \$60.00/quarterly for Consolidated Water District 101 (CSW101) for the 1st 18,000 gallons with an overage charge of \$4.00 per 1,000 gallons in excess of that and will remain the same for 2016. In terms of the Capital Roll, there is a 6% increase. This district has a total of 873.25 units, which is a decrease of 13 units. The rate will increase by \$21.53/EDU for a total of \$375.00/EDU for 2016. Ms. Palmer explained that this could have been higher, but they applied \$23,000.00 from the sale of commercial water. This is a very important component for the debt service in this district. Without that benefit, the rate would have increased by \$47.53/EDU. She noted that this capital charge also applies to Water Districts 2A, 5, 8 and 9, so they will all pay the \$375.00/EDU plus their own capital rate for the existing debt they had prior to consolidation.

Out-of-District Users - The Town tries not to have any out of district users; however, on occasion someone may be in need of hooking up and is just outside the district boundaries so they join as an Out-of-District user. Last year a rate was established to those people. The 2015 rate was \$150.00/qtr. for the 1st 18,000 gallons with an overage charge of \$4.00 per 1,000 gallons in excess of that. The recommendation is to increase that to \$155.00/qtr. for 2016. She explained that this rate includes a component for both O & M (\$60.00) and Capital Costs (\$95.00).

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:25 p.m.

Inglewood, Water District 2a

The public hearing for the Capital Assessment Roll for Water District #2a, Inglewood, opened at 7:25 p.m.

Capital Roll/costs: Inglewood -Water District #2a – The district has 33.50 units, which is an increase of 1.50 units from 2015. This district will see a rate increase of 33% in their individual district of \$69.62 to \$240.69/EDU. When you combine the CSW101 rate of \$375.00 with the increase in the capital charge for SW2A, it culminates in a total increase of \$91.15/EDU for 2016 or \$615.69/EDU.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:28 p.m.

Miller Rd.-Exit 10, Water District 5

The public hearing for the Capital Assessment Roll for Water District #5, Miller Rd./Exit 10, opened at 7:28 p.m.

Capital Rolls/Costs: Miller Rd./Exit 10 - Water District 5: This district had 1,423 units in 2015 and that remains the same for 2016. This district will see a rate decrease of 4% in their individual district (\$.57) to \$18.30/EDU. When you combine the CSW101 rate of \$375.00 with the decrease in the capital charge for the individual district (18.30), the overall capital charge for 2016 will be \$393.30/EDU.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:29 p.m.

Schodack Center, Water District 8

The public hearing for the Capital Assessment Roll for Water District #8, Schodack Center, opened at 7:29 p.m.

Capital Roll/Costs: Schodack Center - Water District 8: This district has 249.75 units which is a decrease of 13 units. This district will see a rate increase of 7% in their individual district (\$13.98) to \$245.85/EDU. When you combine the CSW101 rate of \$375.00 with the increase in the capital charge for the individual district, the overall capital charge for 2016 will be \$620.85/EDU.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:30 p.m.

Route 20, Water District 9

The public hearing for the Capital Assessment Rolls for Water District #9, Route 20, opened at 7:30 p.m.

Capital Rolls/Costs: Route 20 - Water District 9: This district has 179.75 units which is a decrease of 9.50 units from 2015. This district will see a rate increase of 7% in their individual district (\$15.92) to \$224.43/EDU. When you combine the CSW101 rate of \$375.00 with the increase in the capital charge for the individual district, the overall capital charge for 2016 will be \$599.43/EDU.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:30 p.m.

Public Hearings - Capital Assessment Rolls & Operation and Maintenance Rates for Sewer Districts

At 7:30 p.m., the Supervisor called the public hearings to order for the sewer districts. The Town Clerk read the Affidavit of Publication to receive input on the Operation and Maintenance rents for Sewer District No. 1 – Castleton, Town Outside Village; Sewer District 2 - Castleridge, Sewer District 4 – Brickyard; Sewer District 5 – East Schodack; Sewer District 6 – Exit 10/Miller Rd., Sewer District 7 – Hamilton Printing and Sewer District 8 – Schodack Landing. The hearings to receive input on the capital rolls were held at the same time for Sewer District No. 5 – East Schodack and Sewer District 8 – Schodack Landing. The Affidavits appeared in the 10/20/2015 edition of the Record and posted on the Town Clerk's signboard on 10/20/2015.

The Assistant Comptroller led the public hearings for the sewer districts. She explained that the only district with a recommended O & M rate increase is Sewer District #5. Giving a brief overview, she explained that Sewer District #6 purchases their service from the Town of East Greenbush; sewer districts #1, #2, #4 and #7 are served by the Village of Castleton. The only districts with their own treatment sites are Sewer District 5 (East Schodack) and Sewer District 8 (Schodack Landing).

East Schodack - Sewer District #5

The public hearing for the Capital Roll and rents for Sewer District #5, East Schodack opened at 7:31 p.m.

Operation & Maintenance - The proposed semi-annual rate will increase from \$385.00 to \$425.00 semi-annually for 2016. She said this is a difficult district because there are only 27 users which makes it hard to lower rates. Besides the limited number of users, it is a labor intensive system. Our Sewer Operator spends about 10.5% of his time at that district which has to be divided among the 27 users. She added that, in reality, the actual charge should be \$457.22 but there is a small fund balance which allowed them to recommend the lower charge. Unfortunately, after 2016 any fund reserves will be utilized so they will not have that to offset any increases so next year the rate will probably be equal to the actual cost.

Capital Rolls/costs - This district has two areas that are called the Old and the New. One is the original debt (old) and the other is the debt for the upgraded improvements. The New includes all of those people in the Old debt plus 2 more parcels. The units in both portions remain unchanged at 30 and 32 respectively. Regardless of whether you are on the old roll or the new, since the users are essentially the same, the capital charge for 2016 will be \$423.72/EDU semi-annually, which represents a combined rate increase of \$24.08 or 6%. S. Dowds said everyone feels very badly about the rate for this district and they are currently trying to review any options that could lessen the burden for them. Unfortunately, with only 27 users and a system that requires frequent maintenance, it makes it extremely difficult. He noted that their costs for the mandated licensed sewer operator is about \$1200/yr. and DEC required testing costs them about \$1700.00/yr. The Town is hoping to have their own sewer personnel become licensed sewer operators. This

should reduce those fees, but it would not eliminate the operator costs.

Public Comment

One person said he is new to the area and has two units on one piece of property. He said he bought the house because it had an in-law apartment. In addition to the high costs they are charged, it was his understanding that the system does not function well. He assumes that costs will spiral upward in the future. He added that his property is across the street from the system and does not drain into the system. He asked if there was anything that would legally prevent him from opting out of the district if he installs his own septic system. Atty. Ryan said there is a process that must be followed under Article 12 of Town Law. In essence, it allows the Town Board to consider it; however, a resident cannot simply opt out of the system by submitting a request.

As everyone wishing to speak was heard, the Supervisor closed the public hearing at 7:41 p.m.

Schodack Landing – Sewer District #8

The public hearing for the sewer rents and Capital Roll for Sewer District #8, Schodack Landing, opened at 7:41 p.m.

Operation & Maintenance – This district has no change in the number of units (68) The proposed semi-annual rate will remain the same at **\$180.00/EDU**. They are accumulating a nice fund balance which will assist them in paying pump-out charges.

Capital Rolls/costs – This district has no change in the number of capital units (75.25). The capital rate will decrease by \$9.46 from last year (2%) due to the debt service schedule. The Capital Rate for 2016 will be **\$418.43/EDU**.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:43 p.m.

The following districts do not have any debt service (Capital charges). They are serviced by other entities.

Exit 10 - Sewer District #6

The public hearing for the sewer rents for Sewer District #6, Exit 10, opened at 7:43 p.m.

Operation & Maintenance – This district, which is the only district billed quarterly, is serviced by the Town of East Greenbush and has 54 users. Their sewer rate is determined by water consumption. The current rate is \$7.30/1,000 gallons and will remain the same for 2016.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:44 p.m.

The following sewer districts are serviced by the Village of Castleton.

Castleton (Town outside Village) - Sewer District #1

The public hearing for the sewer rents for Sewer District #1, Castleton, opened at 7:44 p.m.

Operation & Maintenance – This district has 95 users. The proposed semi-annual rate for 2016 will remain at **\$145.00/EDU**.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:45 p.m.

Castleridge – Sewer District #2

The public hearing for the sewer rents for Sewer District #2, Castleridge, opened at 7:45 p.m.

Operation & Maintenance – This district has 54 users. The proposed semi-annual rate for 2016 will remain at **\$210/EDU**.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:46 p.m.

Brickyard – Sewer District #4

The public hearing for the sewer rents for Sewer District #4, Brickyard, opened at 7:46 p.m.

Operation & Maintenance – This district has 2 users. The proposed semi-annual rate for 2016 will remain at \$340.00/EDU.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:47 p.m.

<u>Hamilton Printing – Sewer District #7</u>

The public hearing for the sewer rents for Sewer District #7, Hamilton Printing, opened at 7:47 p.m.

Operation & Maintenance – This district has 1 user with 12 units. The proposed semi-annual rate for 2016 will remain at \$155.00/EDU.

The Supervisor stated that he is cautiously optimistic that there could be a new business in that building. He said no one has actually come from the Planning Board so he did not have any details but he knows that someone has expressed interest in the building.

Public Comment - None.

As there was no public comment, the Supervisor closed the public hearing at 7:48 p.m.

Public Hearing

ESTABLISHMENT OF STEWART'S SHOPS EXTENSION TO SCHODACK CONSOLIDATED WATER DISTRICT NO. 101

The Supervisor called the Public Hearing on the Extension to Consolidated Water District No. 101 to order at 7:48 p.m.

The Town Clerk read the notice of public hearing for the establishment of Stewart's Shops extension to Schodack Consolidated Water District No. 101 (CSW101) which is done pursuant to Article 12 of the Town Law of the State of New York. The public hearing is to solicit public comment on the petition requesting the extension and the Map, Plan, and Report. It is noted for the record that the legal notice was duly noticed in the October 19, 2015 edition of the Record and posted on October 19, 2015.

Attorney Ryan stated that the Map, Plan and Report was duly filed in the Office of the Town Clerk. He explained that Stewart's is building a store on a 2.491 acre parcel in the Town of Schodack. The source of supply for the water will come from the Village of Nassau. The Town of Schodack and Village of Nassau will have to enter into an agreement for the sale of water for this property and he is working with the Village Attorney to formulate the agreement. The Map, Plan and Report sets forth the improvements that will be made and related costs. In summary, the maximum cost for this extension is \$94,775 and for the first year, the capital charge for the debt service will be \$2,396. and the estimated water usage (O & M) cost will be \$1,580.00.

Public Comment - None

As there was no public comment, the Supervisor closed the public hearing at 7:52 p.m.

Adoption of Resolutions (Voted Out of Sequence)

The resolutions voted upon reflect additions, deletions and amendments approved by the consensus of the majority Board.


Public Hearing

2016 Preliminary Budget


The Supervisor called the Public Hearing on the 2016 Preliminary Budget to order at 8:10 p.m.

The Town Clerk read the notice of public hearing for the preliminary budget. It is noted for the record that the legal notice to receive public comment on the Preliminary Budget was duly noticed in the October 26, 2015 edition of the Record and posted on October 22, 2015.


Referring to a Power Point Presentation, Comptroller Paul Harter, gave an overview on the 2016 Preliminary Budget. He began by showing how much of the tax dollar goes to support the town, county, and school budgets. On average, the town receives only 15 cents of the dollar in comparison to the county (22 cents) and school (58 cents). It is the level of government closest to the residents, yet it costs less than school and county services. He noted that this does not include the special districts such as lighting, fire, water and sewer (slide below).



Mr. Harter explained that the Property Tax Cap essentially limits the growth in the real property tax levy that a jurisdiction can collect from one fiscal year to the next to 2%; however, 2% is not necessarily 2% in New York State. Using the slide below, he clarified that the cap is on the tax levy not the tax rate. The tax levy is the amount to be collected via property taxes.



Using the following slides Mr. Harter explained the formulas used to arrive at the tax levy cap and the levy limits from 2015 – 2016.






Our tax base increased .5% from 2015. Taking everything into account, the A Fund increased only \$.02/\$1,000.00 from 2015.




The B Fund is called the Town Outside Village. It covers those services for town residents who live outside the Village of Castleton, such as highway, planning and the building department. The main source of revenue for this fund is sales tax. He noted that the B fund is a financing mechanism for the DB fund (highway) and will be transferring \$1,005,000.00 to the DB fund (see slide below).



The end result is the amount to be raised by taxes increased by \$17,000.00 over last year or 1.24%.




However, the tax rate for the DB fund will remain at \$1.37/\$1,000 so there is no tax increase in that fund.




Finally, when you combine the A fund and DB fund the overall net effect, is an increase of less than .5%. In the following example, if your house is assessed at \$200,000.00 your town tax will go up \$4.00. (see below).



The following chart shows where the revenues come from to support the services offered, the majority being real property taxes.



The slide below summarizes how the money is spent in the Town, the majority of which provides services to the town residents, i.e. – snowplowing, paving and other highway services, police protection, library services, home & community (Transfer Station) and general government support (administration of the town).
