OPERATIONS

Supervisor Peter called the December 29, 2022 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above. C. Kenney was absent.

Briefing of the Agenda

S. Peter gave a summary of all resolutions on the agenda. He noted that, upon review of the salary schedule (2022-344) which had been adopted at the previous meeting, a few errors had been noticed requiring corrections (2022-352). For resolution 2022-358, he explained that, per the Personnel Policy and Procedures Manual, an employee must use excess compensatory time over the allotted thirty-five hours, before December 31st; however, the busy season for the Director of Buildings and Grounds was generally later in the year. Therefore, an adjustment was needed to allow for the Director to use said compensatory time by April 30th instead. All other resolutions were self-explanatory.

Board Comment: C. Swartz questioned the abstract regarding the reimbursement of the Town Clerk for mileage. He said there were two different amounts listed with the same description. P. Harter clarified that the clerk had submitted one voucher, which was charged to two different appropriations codes, based upon the duties that she had performed. The total voucher was \$173.81 which included bank runs for the Town Clerk's Office (A1410.4) at \$98.31 and mileage for elections (A1450.4) at \$75.50.

Public Comment: M. Ruthman of The Spinney Group addressed the board regarding the proposed construction of a housing community off Route 9 by Richwood Drive. He explained that the project had been before the Planning Board for many months, with several concepts being created per recommendations from said board, including a reduction in density. He said he was not in favor of the reduction as the original concept was based upon the Comprehensive Plan, which identified a lack of multi-family housing.

Ultimately, he did concede, and the final concept included a reduction from 272 Units to 200 units, consisting of 192 apartments and 8 single-family homes with recreation areas. He noted that the eight single-family homes would allow for a smooth transition to the development located on Richwood Drive. The project had received a Negative Declaration under SEQR by the Planning Board and was now set to come before the Town Board for a zoning amendment to a Planned Development or PD-2 designation. He stated that the project would include an onsite wastewater system but hoped that it would eventually be connected to municipal sewer in the future. C. Swartz noticed that there was an area not included for development and asked if there were plans for the future. Mr. Ruthman said the public hearing for the PD-2 would set a maximum density and he would not be able to develop the property beyond that without Town Board approval. He added that the southern portion of the 49-acre property would be dedicated to walking trails. C. Bult asked if the eight single-family homes would be rentals. Mr. Ruthman said yes as it was the primary intention of the community to add rental opportunities for residents.

Atty. Langlois informed the board that he had been contacted by a land surveyor from Averill Park regarding property located in the Saddle Club Hill Development which had been deeded to the town. D. Kugler, the owner of the property located to the north of the town property, was interested in conveying a portion of said property to a neighbor; however, upon review of the 1991 subdivision, it was discovered that the property line was incorrect. Atty. Langlois had reviewed the proposed correction and stated that it would have no impact on the town. The next step would be to draft a quit claim deed for the 14,000 sq. ft. property, have the board review and add a resolution on to a future agenda for approval. C. Bult said the process seems straightforward and saw no issue with the matter.
