Supervisor Peter called the May 11, 2023 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

S. Peter asked the board to deviate from the agenda to consider three appointments to the Police Department.

Adoption of Resolutions

The following resolutions were voted upon out of sequence.

S. Peter read the following biographies:

"Justin is a dedicated professional who graduated from Albany High School in 2009. He began his career with the New York State Department of Corrections five years ago, and during that time, he has proven himself to be a reliable and hardworking team player.

As a corrections officer, Justin takes his responsibilities seriously and is committed to ensuring the safety and security of his colleagues and the inmates under his supervision. He has developed a strong set of interpersonal skills and is adept at communicating effectively with people from a wide range of backgrounds and experiences.

Justin is currently a resident of the Town of Schodack and is excited to expand his skill set and take on new responsibilities as a member of the Schodack Police Department. His experience with the New York State Department of Corrections has prepared him well for this new chapter in his career, and he is eager to make a positive impact in his new role."

"Ryan Condo was born and raised in East Greenbush and currently lives in the Town of Schodack. He is the son of retired East Greenbush Police Sergeant Mike Condo. He graduated from Columbia High School in 2011, from Hudson Valley Community College with an Associated Degree in Criminal Justice and from the Zone Five Law Enforcement training academy. He has served as a Deputy Sheriff for 4.5 years with the Rensselaer County Sheriff's Office, Highway Patrol Division as well as has been a firefighter for the East Greenbush Fire Department since 2010."

S. Peter stated that Michael Miller had been an Officer for the Town of Schodack for eighteen years and retired in 2022. He welcomed him back as a part-time officer, bringing his experience and leadership to the department.

All three officers were welcomed to the dais to take their oaths of office by the Town Clerk, followed by a brief recess.

Review of Resolutions

S. Peter summarized the resolutions on the agenda. He noted that there was confusion for the dates established for the Spring Clean-Up days at the Transfer Station; therefore, it had been decided to extend the prices to the following weekend (2023-166). For resolution 2023-177, the Supervisor stated that the town would front the cost for the Viking Gym equipment and be reimbursed by the sponsoring groups over time. With regard to resolutions 2023-181 and 2023-182, S. Peter explained that the town had received insurance money for the totaled Highway Truck; however, to purchase a replacement, the board needed to authorize the difference to be pulled from the capital reserve fund. All other resolutions were self-explanatory.

Board Comment: C. Bult asked if one or both vendors who supplied quotes would be used. S. Peter said it was possible to utilize both. Some roads were quoted less with each vendor and he felt it might be beneficial to potentially get the roads done quicker. C. Bult agreed as it would also be an opportunity to compare the quality of work for each vendor. S. Peter added that as the road program stood, they were on budget; however, if the board chose to dedicate more funds to the program, the Highlands in East Schodack needed to be repaved. C. Bult noted that there were two quotes for Phillips Road, one for only the rough portion and one for the entire length. He asked how it was decided to pave the entire length. S. Peter said, based upon the cost comparison and necessity, it was determined that the entire length should be done. It had also been mentioned that Carney Road needed paving; however, there was potential home construction so it would be best to wait. C. Rex asked if they would continue the road striping program. S. Peter said yes. He welcomed road recommendations from the board and noted that Clove, Muitzeskill and Phillips Road were his suggestions.

Regarding the State Liquor Authority application received from Birch Hill Catering at Stable Gate, S. Peter said that the board decision was made based upon comments from members form the Town Board, Planning Board and Zoning Board of Appeals, along with concerns from residents. He noted that the board would be supplying a favorable recommendation; however, it was the desire of the board to include all comments to the applicant.

Public Comment: None.

Review of Abstracts of Claims and Budget Amendments: The Board reviewed claims #23-0626 to #23-0790 on Abstract No. 2023-05 in the amount of \$469,176.32 including the claims paid prior (\$207,519.60).

competent engineers, prepared an addendum to the original map, plan and report, a copy of which is attached hereto and made a part hereof; and

WHEREAS, within the original map, plan and report filed in connection with the creation of Battisti Water District No. 10, the annual user costs for the typical property equaled \$696; and

WHEREAS, although the maximum cost of the improvements has increased to \$2,735,010, the first-year annual cost for the typical property within Battisti Water District No. 10 is decreasing from \$696 to \$651; and

WHEREAS, the current threshold amount established by the New York State Office of the State Comptroller for the creation of water districts or extensions does not require Comptroller approval if the first-year annual costs to the typical property is less than \$1040; and

WHEREAS, the proposed first year annual cost of \$651 to the typical property owner within Battisti Water District No. 10 is less than the threshold amount of \$1040 established by the Office of the State Comptroller.
