Adoption of Resolutions

WHEREAS, said map, plan and report was prepared by Laberge Group Ltd., competent engineers, duly licensed by the State of New York, showing the boundaries of the proposed water district and the general plan of the proposed water district; and

WHEREAS, by resolution dated July 9, 2020 the Town Board of the Town of Schodack approved the creation of Battisti Water District No. 10 with the maximum cost of improvements equaling \$1,790,000; and

WHEREAS, on November 17, 2021, the town board of the Town of Schodack received approval from the Office of the State of Comptroller to create Battisti Water District No. 10 with the maximum cost of improvements to equal \$1,790,000; and

WHEREAS, thereafter on December 9, 2021 the Town Board of the Town of Schodack resolved and determined to establish Battisti Water District No. 10; and

WHEREAS, the resolution and determination establishing Battisti Water District No. 10 was recorded in the Rensselaer County Clerk's Office on January 11, 2022; and

WHEREAS, after the final resolution and determination establishing Battisti Water District No. 10 was recorded in the Rensselaer County Clerk's Office it was determined that the maximum cost of the improvements for the project increased from \$1,790,000 to \$2,735,010; and

WHEREAS, in connection with the increase in the maximum cost of the improvements for Battisti Water District No. 10 the Laberge Group, Ltd., competent engineers, prepared an addendum to the original map, plan and report; and

WHEREAS, within the original map, plan and report filed in connection with the creation of Battisti Water District No. 10, the annual user costs for the typical property equaled \$696; and

WHEREAS, although the maximum cost of the improvements has increased to \$2,735,010, the first-year annual cost for the typical property within Battisti Water District No. 10 is decreasing from \$696 to \$651; and

WHEREAS, the current threshold amount established by the New York State Office of the State Comptroller for the creation of water districts or extensions does not require Comptroller approval if the first year annual costs to the typical property is less than \$1040; and

WHEREAS, despite the increase in cost to the improvements the proposed first year annual cost of \$651 to the typical property owner within Battisti Water District No. 10 is less than the threshold amount of \$1040 established by the Office of the State Comptroller; and

WHEREAS, the town board of the Town of Schodack scheduled a public hearing pursuant to Section 209-h of the Town Law to be held on June 8, 2023 at 7:05 p.m. at Schodack Town Hall, 265 Schuurman Road, Castleton, New York 12033; and

WHEREAS, at the designated time and place the town board of the Town of Schodack conducted the public hearing at which time all interested parties were heard; and

WHEREAS, the public hearing was thereafter closed.

NOW, THEREFORE, IT IS RESOLVED AND DETERMINED:

Open Discussion

Road Program: S. Peter noted that B. Brahm, Highway Superintendent, had returned to work following the injury to his ankle (non-work related). He said a discussion had occurred regarding the continuation of the road striping program and asked that board members forward their road suggestions to him. He mentioned that he had visited Morey Park Road which had been recently paved. He was very impressed with how it turned out. C. Swartz asked if Schodack Drive would be considered for 2023. S. Peter said no; however, it was on the list for 2024, along with the roads in Clearview, Carney Road and Sunset Road. With regard to Sunset Road, the board would need to decide on whether to make improvements to the road or simply pave the road, as is.

School Resource Officer: S. Peter explained that a joint meeting had occurred between C. Swartz, Chief Natale and him regarding the creation of a School Resource Officer (SRO) position for the Schodack Central School District. It was the desire of the school district to have the SRO position filled for the 2023-2024 school year. The town board was willing to make a good faith effort; however, they could not guarantee the outcome.

Van Hoesen Station: S. Peter said he would be meeting with M. Ruthman regarding the latest draft of the plans for Van Hoesen Station. He noted that Mr. Ruthman understood the concern for traffic congestion; however, it would be the determination from the NYS DOT for the installation of a traffic control device. He added that the new plan included leach fields due to the limited sewer capacity in the area as well as a park that would be dedicated to the town.

Water Meters: P. Harter, Comptroller, explained that the current water meter utilized by the Water/Sewer Department would no longer be supported by the end of 2023. He said that he had received a quote from Ti Sales for two options for meters and the annual cost for the software subscription. Based upon the efficiency of the models, he felt that the Neptune MRX920, at a cost of \$11,207.30, would be the best option as it could read meters at 25 M.P.H. rather than the current model which could only read at 5 M.P.H. He asked that the decision for purchase be made by August, to allow for an integration to occur for the billing cycle in September/October. S. Peter felt the model that P. Harter recommended would be more efficient and cost-saving. He suggested that American Rescue Plan Act (ARPA) funds be used for the purchase. C. Swartz asked if more than one quote had been received. P. Harter said no, as Ti Sales was the only provider.

Transfer Station Events: S. Peter reminded residents that Shredding Day would take place on July 22, 2023 at the Schodack Town Hall Parking Lot and the Household Hazardous Waste Day would be held on July 29, 2023 at the Schodack Highway Garage.
