Supervisor Peter called the October 12, 2023 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Briefing of the Agenda

S. Peter gave a brief review of all resolutions on the agenda. He explained that the price of the Chevy Tahoe had originally been listed at \$67,000.00; however, an additional cost for outfitting the vehicle with lights and a cage brought the price to \$77,000.00 (2023-276). Chief Natale mentioned that he had contacted a company to outfit the vehicle at a lower cost. He anticipated the total vehicle price to drop to around \$70,000.00. C. Bult asked if the resolution should be amended to better reflect the cost but allow for any potential increase. He felt \$72,000.00 would be best. All board members agreed to amend resolution 2023-276 to reflect the new price. The Supervisor stated that the remaining resolutions were as follows: 2023-277 related to the hiring of Cory Morales as an Operator 2 at the Highway Department, 2023-278 would allow for the installation of two stops signs as there were currently no signs at the two intersections listed, 2023-279 established a right away for the new Water Tower to feed the Route 9 Water South project, 2023-280 authorized the transfer of six vacant properties from Rensselaer County to the Town, 2023-281 allowed for the hire of an onsite engineer for the sewer project on Maple Hill Road and 2023-282 authorized the Justice Court to seek a FCAP grant. All other resolutions were self-explanatory.

Presentation – Larkin Hill Farm Conservation Easement

Chris Krahling, Senior Project Manager for the Agricultural Stewardship Association (ASA), addressed the board regarding a conservation easement for Larkin Hill Farm. He explained that the ASA was a not-for-profit land trust with a goal of protecting farmland within Rensselaer and Washington Counties. To facilitate that goal, the land trust purchases properties through conservation easements which limit incompatible development of the land and promote farming. The property is still owned and operated by the landowner, but the easement is monitored by the ASA annually through land and air survey to ensure there is compliance with the terms of the easement. The purchase of the property is done by utilizing grants offered by the NYS Farmland Protection Program through the Division of Agriculture and Markets. He noted that they were currently in round 1 of the grant process to purchase a portion of lands owned by Margaret Hutchison on Woodward Road. For the application process, a letter of support is needed from the Schodack Town Board for the project. He added that the town would not be involved beyond the letter of support. C. Swartz asked if the tax rate would remain the same. Mr. Krahling said yes. It would be up to the Assessor to make any changes. S. Peter asked if the Rensselaer County Farm Protection Board had met regarding the project. Mr. Krahling said and they agreed to send a letter of support as well.

Open Discussion

Paving – Town Hall Parking Lot: S. Peter reminded the board that HMA Paving would begin milling the parking lot on October 13th and pave on October 14th, weather pending. He welcomed all members to check the progress throughout the weekend.
