Supervisor Dowds called the December 10, 2015 meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

### Supervisor's Report

**Kinder Morgan/NED Pipeline:** S. Dowds gave a status report on the Kinder Morgan gas pipeline application. There was a meeting on December 1<sup>st</sup> with the Berkshire Planning Commission. On December 7, 2015 the Federal Energy Regulatory Commission (FERC) authorized their application. He believes that the date to submit for Intervener status will be Jan. 6, 2016. The Berkshire Planning Commission will intervene on behalf of the 15 municipalities associated with the group, which includes the Town of Schodack. The town will also apply for intervener status separately. On December 8<sup>th</sup> FERC sent a letter to Kinder Morgan requesting 15 – 20 pages of additional information. The B.C.K Law Firm is working with the municipalities to provide guidance in moving forward (what to request, how to do so, etc.). Next week Kinder Morgan is hosting three community forums regarding the Northeast Energy Direct (NED) pipeline, one of which will be in Schodack. That one will be held Thursday, December 17<sup>th</sup> at Birch Hill from 6 p.m. – 8 p.m., but he did not know the format of the forum.

Transfer Station Sanitary Facilities & Electronics Container: S. Dowds said he sent several e-mails to the Board regarding the purchase of the sanitary facilities for the Transfer Station and an electronics container and asked for Board input. With regard to purchasing an electronics container, C. Bult suggested that before the Board authorizes this purchase, they should have a broader understanding of future operations. He was concerned that ordering another container might not be necessary, depending on what is decided. C. Swartz said he recalled that the Board discussed having a total assessment of the Transfer Station operations conducted and asked if that had been done. S. Dowds said no; they are currently trying to address some immediate safety issues and single stream recycling. He intended to schedule the assessment for early next year. Board members called upon Mr. Goodall for his input. He explained that the electronics container could be multi-purpose and used somewhere else eventually, but was not an immediate need. With

regard to safety issues that needed to be addressed, he explained that they were working on the fence that separates the public from the disposal container. In one area they need to bring the grade up approximately 42", which would make the disposal of the bags much safer. The Highway Superintendent told him he felt that it probably can't be done until spring. Board discussion continued. Due to the unseasonably warm weather, the Board suggested that perhaps, it could be done now, depending on the Highway Superintendent's scheduling. **Determination:** It was the consensus of the Board to go forward with the purchase of the sanitary facilities, which will be ratified at the Close of Business meeting, and hold off on the purchase of the electronics container.

NYSDEC Water Quality Improvement Program (WQIP) Grant Application: S. Dowds announced that he received informal notification that the Town was successful in its grant application for improvements at the highway garage fueling station, which the Board authorized this past July. When DEC reviewed the area, they strongly recommended that the town consider upgrading or replacing the system and adding a canopy, so when the Board learned about the grant opportunity they submitted an application for \$300,000.00. He is waiting for formal notification, but believes the award amount is \$250,000.00 and the Town will have to pay 25%. He felt that we were very fortunate in getting almost the full amount. He explained that this project would totally replace the entire fueling system at the highway garage, which should extend its life for 25 – 30 years.

**Swearing-In of Newly Elected Officials:** S. Dowds asked the consensus of the recently re-elected officials when they would like to hold the Swearing-In Ceremony. He suggested December 30<sup>th</sup>, but felt it was up to everyone as a group. After a brief discussion, the consensus of all involved agreed with the December 30<sup>th</sup> date and to hold it at 7 p.m. after the Close of Business Meeting. The Town Clerk will contact Judge Peter to see if he is available to participate as well as administer the Oath of Office to them. S. Dowds said he will reach out to Councilperson-Elect Rex to see if she would like to participate in the event. (During the Executive Session the Town Clerk contacted Judge Peter who was in agreement with the time and date).

#### **Board Discussion**

- C. Bult asked the Supervisor for the provisions of the police contract (resolution 2015-268). S. Dowds said it is a 4 year contract and the highlights are as follows:
  - 1) Bi-weekly payrolls
  - 2) 1.75% increase in 2016; 1.75% increase in 2017; 2% increase in 2018 and a 2% increase in 2019.
  - 3) The 207-C determination will be revisited in 2017.
  - 4) Increased benefits for the dispatcher.

With respect to resolution (2015-278), the Supervisor stated that the Capital District Transportation Committee (CDTC), who is directing this study, requested a few people to assist them with the zoning study. Board members asked if the individuals that were appointed to the first committee were asked to serve on this one. S. Dowds said no, because this is more specific. With no disrespect to those noted in the resolution, C. Kenney felt that there should have been more Board discussion about the appointments. C. Swartz agreed. Following a brief discussion, it was the consensus of the Board to withdraw the resolution from the agenda and revisit it at the Close of Business meeting on December 30<sup>th</sup>.

Board members questioned why resolution [2015-272] was necessary at this time. S. Dowds asked HR Manager, Kerrie Joiner to address the Board. Ms. Joiner explained that it

is essentially to help her and the Board regarding labor issues. The consultant would provide unlimited telephone and email consultation regarding human resource and labor relations questions in a timely manner and help keep her compliant with federal and state regulations and procedures. C. Swartz asked if it could be done on a month-to-month basis, rather than an annual contract. S. Dowds said no. C. Kenney asked the status of the Employee Handbook. S. Dowds replied that it was sent to the Board for their review and input. Board discussion ensued. C. Kenney stated that he has a problem spending more money when the Handbook is still not finalized. Concerns were also expressed that some of the funds in this resolution would be used for completion of the handbook. Ms. Joiner said that would not happen as it is a separate contract.

#### **Public Comment**

Carrie Watkins-Bates addressed the Board regarding a letter of support for a grant that the Columbia Land Conservancy (CLC) is submitting to the New York State Hudson Valley Agricultural Enhancement Program. The purpose of the grant is for the purchase of development rights for the approximate 148 acre Harian parcel on the Dutch Hollow Farm which is owned by the Chittenden family and located in Schodack. Dutch Hollow is a multigenerational dairy farm with the second largest Registered Jersey herd in the state. The family has already protected the majority of their farm with conservation easements, and protection of this additional piece would further ensure their long-term stability and success. Protection of the farm would clearly further the Town's goals and objectives for farmland protection as outlined in the 2011 Comprehensive Plan. She continued that they work in conjunction with the Agricultural Stewardship Association (ASA) which is submitting a similar application on behalf of GEM Farms, which is owned and operated by the Mesick family. The 540-acre farm operation is a very diversified, selling beef, bison, hay, corn, soy and vegetables. Approximately 312 acres of the proposal are owned by the Mesick family and the remaining 228 acres included in the application are owned by Terre D'Or LLC (Olga and Resa Swartz). Ms. Bates continued that ASA and CLC are nonprofit land trusts which help landowners conserve farmland. Their goal is to ensure that future generations can continue to enjoy the local agricultural traditions, landscapes and products. conserved farm contributes to the vison for the continued vitality of agriculture in our region. Once land is protected by a conservation easement, ASA and/or CLC take on the permanent responsibility for stewardship, including annual visits and meetings with landowners to ensure that conservation goals are met. She reiterated that the only involvement the Town has is doing the letters of support. ASA and CLC submit and administer the grants. C. Bult asked if there were minimum requirements for submitting an application. Ms. Bates explained that the state program looks at the quality of the land, the size of the parcel and the type of agricultural uses. C. Curtis said he served on the Agricultural Committee for ten years in his position as the Director for Real Property Tax Services for Rensselaer County and helped craft the Right to Farm Law for the Town and he is a strong advocate for the farming community. C. Bult said Schodack has always been identified as a farming community and felt we should do whatever we can to support the farms. It was the consensus of the Board to add a resolution to send letters of support.

M. Sherwood expressed concern about certain zoning violations in her area that seem to have gone unresolved. The Supervisor said he believed that some of it was addressed and suggested that she speak to the Code Enforcement Officer, Mr. DeFruscio about her concerns.

Relative to the NED pipeline, K. Stokem expressed concern over potential damage to town roads if the project goes through. He asked if the Town had a weight limit law for town roads and if Kinder Morgan would be required to post a bond if the town roads are damaged. The Supervisor said that is one of the issues they are going to bring up when they apply for Intervener status.
