Supervisor Dowds called the February 12, 2015 meeting to order at 7:05 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Departmental Reports

The following monthly departmental reports were read and/or posted and filed in the Office of the Town Clerk: Town Clerk, Building Department, Transfer Station, Historian and Police.

Review of Abstracts of Claims and Budget Amendments

The Board reviewed claims #15-0119 to 15-0324 on Abstract No. 2015-02, in the amount of \$1,736,790.31, including the claims paid (\$246,799.66).

Briefing of Resolution Agenda

C. Curtis asked for clarification of the resolution to further amend resolution [2014-211]. S. Dowds explained that they were adding \$20,000.00 for the professional services relative to the tax certiorari for Resurrection/Riverside Nursing Home, which was discussed at the Jan. 22, 2015 workshop. C. Bult asked for more information regarding resolution [2015-086]. S. Dowds explained that we submitted the grant application last year and it was subsequently awarded to us. The resolution essentially accepts the grant for the water quality improvement project for stormwater mapping and acknowledges that the Town has to pay 25% of the project costs of \$24,500.00 or \$6,125.00. S. Dowds called upon Nadine Fuda, Project Director, to give a brief overview of the intended project. Ms. Fuda explained under the DEC MS4 program we are mandated to have all the Stormwater outfalls and inlets mapped by 2017. The project will be done by Laberge, who will follow all the inlets and outlets to see where our watershed is traveling. Ms. Fuda said they will be doing this using

pictometry and some field work. S. Dowds noted that paragraph III of resolution [2015-097] should be amended to show that the total amount levied was \$3,581.32, not \$3,5821.32. With regard to resolution [2015-097], Atty. Gruenberg asked if there was a simpler way to accomplish the deduction for the franchise fee. C. Curtis said, unfortunately, no. It is because of the language in Section 626 of the Real Property Tax Law. Time Warner can request the municipality with whom they have a franchise, to pay their town taxes. The Supervisor said it would be easier to just deduct the taxes from the \$81,867.69 in franchise fees for 2014, but it cannot be done that way, and they have to do this every year.

Public Comment

- D. Spilman asked if the Board knew if the gas line company (MorganKinder) had rescheduled their public meeting. S. Dowds said we have not received any information regarding a new date. Mr. Spilman felt the Board should get more detailed information on the proposed compression station which could be a sound issue given the 90,000 HP operation. Also there should be more detailed information on the plan to maintain the buried pipe from rusting (cathodic protection). S. Dowds explained that his comments would be better directed at the federal agency that will be overseeing the project. Mr. Spilman felt the governing body might have more influence than a single individual in obtaining the information. R. Lemka asked the proposed path for the gas line. S. Dowds said he believed they would be following the existing right-of-way of Tennessee Gas until Lape Rd. From there it will utilize the National Grid right-of-way through Schodack, Nassau and Stephentown into Massachusetts.
- M. Sherwood asked why the town was entering into an independent contract with the webmaster. S. Dowds said because that is the way it has been done. The contractual agreement was for \$8,240.00, but \$100.00 of that was for the google search ability for our website; therefore, his actual remuneration is \$8,140.00. Ms. Sherwood said the agenda was, again, not available for public review on the site. The Supervisor explained that the webmaster was on a cruise and brought his laptop so he could continue to do his job, but the ship did not accommodate him. He continued that his office is currently looking into other alternatives for a website. C. Kenney said this is very frustrating for the board as well. The Supervisor agreed and was targeting the end of the year for a change. The Board discussed whether they should change the language of the contract to make it for a monthto-month basis. S. Dowds said he would like to see a more user friendly website so that department heads can actually post their information. Board members felt that was a good idea as it will be easier to assess accountability for timely postings. While it will give the town more control and flexibility, it probably comes with a higher cost; however, the end result should be a better and more current product. Ms. Sherwood said she thought that the Board had agreed that they would look more closely at their expectations from the current webmaster and communicate them to Mr. Wheeler. The discussion continued and at its conclusion, it was the consensus of the Board to withdraw resolution [2015-078].
- R. Lemka said he was encouraged to hear the discussion about the website and webmaster. He questioned whether the costs would be much higher than they are paying now because so many options are available. With regard to resolution [2015-079], Mr. Lemka asked what the addendum was that was being removed. S. Dowds explained that it was simply for miscellaneous planning & zoning work that they feel is not needed at this time; however, they are doing a different addendum to have them assist with the zoning

amendment for solar facilities, resolution [2015-082]. Mr. Lemka said he believed he mentioned that the Board should have regulations regarding solar facilities about 6 months ago. He said they are popping up all over town and suggested that the Board consider passing a moratorium on solar facilities until they have the regulations in place. With regard to the mapping resolution, he asked if run-off from road salt would be part of the project. The Supervisor said no. Mr. Lemka thought that at the last meeting the Board put a cost on disposable of TV's. The Supervisor said that was correct. The previous vendor was charging the town so they had to charge for the TV's; however, the vendor that they are contracting with tonight will not be charging the town so they are amending the regulations to eliminate that charge to the residents.

T. Plante suggested that if the town needs to enter any private property during the mapping project, that homeowners be notified. Ms. Fuda said they will be working on the street right-of-ways.

WHEREAS, Section 626(2) of the Real Property Tax Law provides that the person responsible for collecting the franchise fee shall deliver to the Town of Schodack a certificate showing the amount of the franchise fee paid for the year ending on the date set forth in the certificate, and

WHEREAS, upon receipt of the certificate, the law requires the Town of Schodack to enter a credit on the tax roll in the amount shown on the certificate, and

WHEREAS, Rensselaer County Bureau of Finance is responsible for entering the credit on the tax roll, and

WHEREAS, pursuant to Section 626, the TWC Tax Department returned the Town's Special Franchise tax bill, and

WHEREAS, TWC is required to make a request in order to receive a credit on the tax roll, and

WHEREAS, the Town has received a request for the credit on property taxes assessed in 2015 from the franchise fees paid during 2014,
