Supervisor Dowds called the September 11, 2016 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Departmental Reports

The following monthly departmental reports were read and/or posted and filed in the Office of the Town Clerk: Town Clerk, Building Department, Highway Department, Planning & Zoning, Receiver of Taxes and Assessor.

Review of Abstracts of Claims and Budget Amendments

The Board reviewed claims #16-1325 to #16-1454 on Abstract No. 2016-09..

Briefing of the Resolution Agenda Discussion-Resolutions

S. Dowds briefed the Resolution Agenda. With regard to Resolution [2016-205], the Supervisor explained that Mr. Cirillo applied for an area variance but changed his mind and withdrew his application. Resolutions [2016-206] and [2016-207] waive the requirement to hold the water/sewer rate hearings by October 20th. He stated that the Board waives that requirement every year. With regard to Resolution [2016-209], S. Dowds explained that the cost of the historical marker is \$1200.00. The Castleton Cemetery Association asked the Town if they would be willing to fund one-third of that cost. The remaining two-thirds will be shared equally with the Association and the Village of Castleton. On behalf of the Board, C. Bult will be presenting the Proclamations to the Eagle Scouts (Resolutions [2016-212] & 2016-213]). All other resolutions are self-explanatory.

Public Comment

Resolution [2016-205]: Norm Wiley, President of the Castleton Cemetery Association, thanked the Board for their consideration in funding the historical marker for the cemetery. He said they hope the marker will draw attention to the significance of the cemetery and the rich cultural history of the cemetery as well as the community.

Resolutions [2016-206] and [2016-207]: K. Stokem asked why the Board traditionally waived the hearing dates for the water/sewer rates. The Supervisor said they normally conduct them the beginning of November. Mr. Stokem asked if there was a reason that the Oct. 20th was put in the Code. S. Dowds said that date is required by State Law.

K. Stokem asked for an update on the status of the LWRP Joint Committee. S. Dowds replied that it does not appear that it will be moving forward at this point; however, the LWRP is a viable document and is still in place. Mr. Stokem said he understood that the Village of Castleton recommended four members. S. Dowds explained that the Town and Village can select four members each and then the appointment of the Chair is a joint recommendation from the Supervisor and the Mayor. The standstill is regarding the selection of the Chair. Mr. Stokem asked the intended role of the Committee. S. Dowds said their only charge was going to be updating the document, which, in his opinion, was a fairly stable document even today.

The Comptroller noted that the monthly Abstracts are always posted on the Bulletin Board in the meeting room for public review. Mr. Stokem asked if it was possible to upload them to the website like the rest of the meeting information. The Comptroller explained that he does not normally get them finalized until late in the afternoon of the meeting date, whereas, the other information is presented with the agenda several days prior to the meeting; however, he would be willing to post them on the website shortly thereafter.

Board Discussion/New Old Business:

SLA Request: The Supervisor noted that the Deputy Town Clerk recently sent the Board a State Liquor Authority (SLA) request that "Delz Dawgs" was going to open as another restaurant *(Town Clerk clarification - new operator)*. C. Bult said he understands that the applicant will be going before the Planning Board at the upcoming meeting, and after reading the application to the SLA, he has some questions regarding some of the items indicated on the form. The Town Clerk asked if it was regarding the music and other activities that were selected on the form ("will you have a DJ, Karaoke, a band, etc."). C. Bult said yes. She stated that the Deputy Clerk called the applicant about those items and

was told that he was advised to select those items now just in case they wanted to offer that in the future; however, they are not considering them at this time. C. Bult said he wants to hear the presentation at the Planning Board because he has concerns about the amount of room at that facility and, based on the SLA application, he doesn't really understand their business plan.

Dunkin' Donuts Sewer: C. Kenney asked the status of the Dunkin' Donuts Sewer issue. S. Dowds said he tried contacting Mr. Leal but he has been on vacation so he spoke with Ron Laberge today. They are getting estimates on the fencing. That and other items on the punch list will come out of escrow as well as anything we deem as necessary as a result of their operation. So at this point we are covered financially. Mr. Laberge is well aware of our position regarding the PH, wherein we will issue an Order to Remedy if they don't put the equipment on the premises. C. Kenney felt the issue with the low PH has gone on long enough and there should be a more expedient resolution. C. Swartz asked if there was a termination date on the escrow account. S. Dowds said no. C. Kenney asked if there was enough money in the escrow account to address the PH problems that exist at their facility. The Supervisor said he believed so because they don't need a significant amount of equipment. C. Kenney said he would like a date certain that the problem will be corrected and asked that this discussion be continued at the next meeting because he was very concerned about the pump station behind Rensselaer Mobile Home Estates. C. Bult asked Atty. Gruenberg if there was a mechanism for the town to actually levy fines against Dunkin' Donuts if they don't comply. S. Dowds said yes. It is in the Town's Code. After the Order to Remedy is issued, the fine is \$250.00/day. A. Gruenberg said the issue is whether the ability to issue an Order to Remedy extends to the nature of the effluent. Dennis said he believed it did because the Code states the PH has to be no lower than 5.5 and theirs has been as low as 3.8.

East Greenbush Sewer: C. Bult asked if there was any update on the discussions with the Town of East Greenbush regarding our Sewer Agreement. Dennis said he spoke with "Jack" from East Greenbush about 10 days ago and they are working on it. He said our Assistant Comptroller, Laura Palmer has all the documentation and they have agreed to meet with them and their consultant to discuss the amount of flow and the rates. C. Kenny explained that the new East Greenbush sewer plant is now on-line and they will have to start making payments on it. Rather than levying those costs as a capital costs, they have chosen to add it on the usage charge of the current sewer users in East Greenbush, which also allows them to increase the rates for Schodack users.

Executive Session

C. Swartz made a motion at 7:25 p.m. to enter into executive session to discuss personnel appointments in the Building and Planning Departments. Seconded by C. Rex.
