Where by B & L Control Service Inc. agrees to supply chemical products, services and other assistance as stated below to the above named institution for a one year from the above indicated date for the sum of \$2,468.00 plus applicable NYS Sales Tax.

By this agreement, B & L Control Service Inc. is to supply sufficient, effective chemicals, and they are to provide supervisory service for the addition of chemicals to the below listed systems.

SYSTEMS TO BE TREATED

1. Pan water loop on the evaporative cooler
2. Heat pump/hot water recirculating
3. Glycol Loop

An adequate amount of service calls will be made at which time a check will be made on all phases of these programs. We will check chemical levels and provide additional chemicals when needed, run tests and provide a report of all test results, check to make sure equipment is working correctly and repair and / or replace equipment when needed. Repair and/or replacement of any parts or equipment will be supplied at an additional cost. Upon completion of each service visit a service technician will leave a service report with their comments and recommendations.

B & L Control Service Inc. will use Eastern Technologies, Inc.'s of, Morgantown, P.A. laboratory facilities for analytical work and consultation in connection with the water treatment program.

B & L Control Service Inc. agrees to provide proof of holding a New York State Pesticide Applicator Business Registration and to provide a New York State Registered Pesticide Applicator to do the service work in regards to applying the biocides to the cooling towers. B & L Control Service Inc. further agrees to use only New York State Registered products for use in controlling bacteria in the water systems and report all pesticide usage to the New York State Department of Environmental Conservation on a yearly basis as required by New York State Law.
