OPERATIONS

Supervisor Harris called the January 11, 2018 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Brief of Resolutions

S. Harris explained the public hearing for Proposed Local Law 1-2018 would not begin until 7:30 p.m. In the interim, he read through the resolutions. In regards to resolution 2018-071, an addition had been made to the schedule to include the acceptance of credit cards as payment at the Transfer Station. All other resolutions were self-explanatory.

Board Comment

Resolution 2018-073: C. Bult said he had emailed D. Kelly earlier in the week regarding the fire investigation budget. He noticed there were funds in the contractual (.4000) but nothing was specified for training. Upon discussion, a suggestion was made to make a budget modification to move funds from an obsolete vendor (Roberts & Nicholas Fire Apparatus) to the training line. S. Harris asked if the funds would be remaining in contractual. C. Bult explained they would remain in the .4000 but be transferred to a different budgetary line. This would make it easier to understand where money was being spent. P. Harter stated a budget modification would not be necessary as the funds are already accounted for. C. Swartz mentioned he felt it was a good idea the appropriations code was added to the resolutions to help understand where the funds were being spent and could be used as a reference to see where the funding is located.

Resolution 2018-069: C. Bult asked if S. Harris would be the only one attending the Annual Meeting for the Association of Towns in February. S. Harris said D. Curtis, Town Clerk had declined to attend due to her injury.

Public Comment

M. Sherwood said she had read an article in the local newspaper regarding a police call for an incident on Maple Hill Road. She was wondering why the County Sheriff was called to respond instead of the Schodack Police. S. Harris said the Sheriff responded because he was the closest car to the scene. He said it was his understanding that when a call is dispatched, it is relayed to all who cover the area including Schodack, Sheriff, and State Police. He stated that Schodack had originally responded to the scene looking for the individual and had left to locate him at another residence. He then returned to the residence on Maple Hill Road at which time the homeowner call 9-1-1 again and the Sheriff happened to be the closest unit. S. Harris added that he had spoken to Sheriff Russo and the situation had been handled in a safe and professional manner.

T. Plante explained his home was appraised at \$400,000.00 and was appalled by the appearance of many residences along Route 20 heading toward the Town of Nassau. He stated the residences include overgrown lawns, missing siding and numerous junk cars. He had spoken to the previous Supervisor who failed to resolve the issue. He hoped the new administration would utilize the Building Department to start enforcing code violations. He added he was pleased to see that the new Town Clerk offered Saturday hours for the benefit of the residents. S. Harris assured Mr. Plante that he would speak to the Building Inspectors and see what needed to be done. M. Sherwood stated that she and another resident had compiled a map of residences that were in violation of Town Code which was submitted to the Planning & Zoning Department but nothing was done.

Departmental Reports: The following monthly departmental reports were read and/or posted and filed in the Office of the Town Clerk: Town Clerk, Building Department, and Historian.

Review of Abstracts of Claims and Budget Amendments: The Board reviewed claims #18-0001 to 18-0112 on Abstract No. 2018-01, in the amount of \$289,073.33, including the claims paid (\$38,930.88) since the previous town board meeting.

Open Discussion

- S. Harris wished to thank the students from Columbia High School's Participation In Government class for attending the board meeting. He was pleased to have had time to speak to a few of them regarding their aspirations.
- B. Goodall mentioned new gates had been installed at the Transfer Station to replace the ones that had been damaged. He said he had been investigating the installation of a

movable gate but was not sure if the current posts would be strong enough to support it. C. Bult asked if he had received word from DEC on being an exempt facility. B. Goodall said he had not submitted the registration and would need to reapply for the exemption. He explained it would require engineering and they would be limited to twenty cubic yards per day. C. Bult asked when the deadline to apply was. B. Goodall said May 4th and noted Washington County was having issues with their exemption application being approved. He said he would keep the Board informed. S. Harris said the Town was lucky to have a Transfer Station. Upon speaking to other local town officials at the training he had attended, he found that other municipalities did not have their own facilities and it was difficult for them.

Public Hearing Cold War Veteran Exemption

S. Harris called the public hearing to order at 7:32 p.m. to authorize the extension of the limited real property tax exemption for Cold War Veterans as amended by Chapter 290 of Laws of 2017, Section 458-b of State Law by which Towns were authorized to extend such exemption for as long as the owners of real property remain as qualifying owners.

The Town Clerk summarized the Affidavit of Publication regarding the extension of the Cold War Veteran Exemption. The legal notice was published in the January 3, 2018 edition of *The Record,* as well as posted on the Town Clerk's signboard and the Town's website on January 3, 2018.

S. Harris called upon Atty. Mullahy to lead the public hearing. Atty. Mullahy explained according to the Real Property Law of 2007, any Veteran who served in the military from September 2, 1945 to December 26, 1991 was eligible to receive an exemption of up to 10 percent on their primary residence. The Town had passed Local Law #2 of 2008 authorizing the exemption to be applied for a ten year span; however, state legislation in June of 2017 authorized Towns to extend the exemption by local law for the duration of time that the Veteran owned the property.

Public Comment: None.

Upon receiving no public comment, S. Harris closed the public hearing at 7:35 p.m.
