Supervisor Harris called the June 14, 2018 Town Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Briefing of Resolution Agenda

S. Harris gave a brief review of the resolutions. With regard to resolution [2018-171], S. Harris explained the prior resolution appointing the town attorney needed to be amended to appoint Girvin & Ferlazzo, P.C. as town counsel with Atty. Mullahy as their representation. As for resolution [2018-178], an additional counselor was needed for the summer day camp to accommodate for a few campers with special needs. All other resolutions were self-explanatory.

Before the Supervisor opened the meeting to public comment, Atty. Danaher explained that there seemed to be a bit of confusion regarding the town board's role in the approval of projects. He stated that the town board is involved in approving changes to be made to the Zoning Code. It is the sole decision of the Planning Board to approve site plans for such projects as the sales distribution center.

Public Comment

Distribution Center/Route 9: B. Jansing of Star Terrace read a statement asking the board members for their opinion regarding a Type I SEQR for the proposed sales distribution center. Atty. Danaher explained, during a public comment period, the board generally would only listen and refrain from comments or opinions. S. Harris recommended Mr. Jansing forward his request to the Planning Board. B. Jordano said he had attended a meeting with Scannell Properties. He felt the meeting left residents with concerns regarding the added traffic that would be traveling on Route 9. He noted the speed limit on Route 9 is 55 mph but at the Route 9 & 20 split, it is reduced to 45 mph. He suggested the speed limit

be reduced on Route 9 to 45 mph extending past the Richwood Drive intersection and increase to 55 mph in a safer area. C. Bult explained the Supervisor could petition the NYS DOT, following the passing of a board resolution, to conduct a study to assess the need for a reduction in speed in that area. Atty. Danaher added the Planning Board would make the recommendation to the Town Board for the change in speed during their review of the site plan application.

Resolution [2018-168]: K. Stokem said he had concerns with regards to his driveway with the method being used to install the sewer line down Maple Hill Road and asked if boring or trenching would be done. C. Kenney said it could be a combination of both but he was not certain. He suggested Mr. Stokem visit the Supervisor's Office or N. Fuda and review the plans.

Resolution [2018-169]: K. Stokem asked if the town would be borrowing the money to fund the sewer installation. C. Bult said the town would not be borrowing but would be supplying the funding and the school district would be repaying the town. S. Harris added it would be a pass through. P. Harter explained the funding for the project would come from the fund balance from the general fund and under the advice of counsel, the board should pass a resolution for the potential issuance of serial bonds in the event the school is unable to repay.

Resolution [2018-170]: K. Stokem asked if the town takes over maintenance of the roads of Spinney, how it would be an advantage to Schodack. Atty. Danaher stated most projects, if constructed to town standards, would be consider for the town to take over the roads. This ensures that the town will not incur added costs to make improvements. Mr. Stokem expressed his concern that the road, which comes to a dead end, would only be a benefit to the homeowners who reside there and would be a rise in cost to taxpayers. C. Kenney said the benefit would be to the community by bringing more residents to Schodack which would help the school district which is observing a large decrease in enrollment. S. Harris added the road could be extended to create more homes. Atty. Danaher summarized that Mr. Stokem was concerned that the town would be taking over the road and it would have no benefit to the taxpayers.

Shufelt Road: J. Sober explained he resides on Shufelt Road and thanked the highway department for paving it. He said it is generally used as a short-cut from Route 20 to Route 9 and sees a large amount of traffic. He stated his residence is located on a dangerous corner and though the speed limit is 35 mph, it is rarely abided by. He asked that the police make additional patrols to enforce the speed and have the highway department post a blind driveway sign on the curve. He was concerned because an accident had already occurred, not even a week after the paving. S. Harris said the preliminary report stated speed may not have been a factor in the accident. Mr. Sober wondered if the speed could be reduced. C. Bult said the town board could not set the speed on town roads but stated the Highway Superintendent could contact Rensselaer County DOT to request a decrease. Mr. Sober asked when the shoulders would be filled to eliminate the drop-offs, making it a bit safer. C. Bult said he had spoken to K. Holmes who assured him they would be filled the following week.

Public Hearing Wm. J. Keller & Sons Construction Corp. Landfill Application

S. Harris called the continuation of the public hearing on a landfill application submitted by Wm. J. Keller & Sons Construction Corp. to order at 7:30 p.m.

The Town Clerk summarized the Affidavit of Publication seeking public comment on an application submitted by Wm. J. Keller & Sons Construction Corp. to operate a sanitary landfill disposal at 1435 Route 9 pursuant to §137 of Town Code of the Town of Schodack. The legal notice was posted on the Town Clerk's signboard and the Town's website on June 4, 2018 as well as published in the June 5th edition of *The Record*.

Public Comment: K. Stokem asked if the application would be reviewed under Chapter 137 of Town Code as it defines a sanitary landfill or under an amendment. C. Bult explained the current code needed to be updated but the application would be judged based on DEC standards as town law cannot supersede state law. K. Stokem asked, regarding Chapter 137-6D, the amount of material that would be compacted each day in the sanitary landfill and what that material would consist of. C. Bult said the term sanitary landfill was not accurate anymore and the material would not be garbage but limited to soil only. K. Stokem asked if the application would indicate the amount of fill that would be deposited and who would monitor the site. S. Harris said yes the application would indicate the amount explained DEC would be monitoring the site. Atty. Danaher added that the town code enforcement officer would also be monitoring the site. S. Harris mentioned the owner intended to eventually put a structure on the property so the site would need to be prepared for construction. Atty. Danaher questioned why the applicant, Mr. Keller, was not present to answer questions from the public. C. Hayes spoke up and indicated he was representing Wm. J. Keller & Sons Construction. Mr. Stokem asked the frequency of inspections which would occur. C. Hayes, who represented Wm. J. Keller, said he assumed they would be under the same standards set by DEC, which includes weekly inspections. K. Stokem asked if a bond would be posted and if so, what the amount would be. Atty. Danaher explained the site would need to be examined to determine the amount of disturbance, the frequency of visits by town personnel and the potential amount of damage done that may occur. Mr. Stokem asked if the bond would be returned once the site was closed. Atty. Danaher said the bond generally could be released once all standards had been met. C. Kenney interjected and suggested the public hearing be continued at the next meeting when Atty. Mullahy, who had been in direct contact with DEC, could be present to answer

Mr. Stokem's questions. A resident asked if the type of material deposited would be similar to the Niagara Falls area where contamination occurred. C. Hayes said they were strictly limited by the type of soil which could be deposited. Atty. Danaher said it was his impression that there was great concern for the material being deposited and recommended the question be posed to the town attorney at a continuation of the public hearing.

Upon hearing no further public comment, a motion was made by C. Kenney to continue the public hearing until June 28, 2018 at 7:15 p.m. and was seconded by C. Swartz.

5 Ayes 0 Noes. **MOTION CARRIED.** Ayes – J. Bult, M. Kenney, S. Swartz, T. Rex, D. Harris. Noes – 0.

Board Discussion

S. Harris asked for an update on the progress made for the playground at the town park. D. Kelly explained renderings and prices had been received from one company but they were waiting on to hear from two other companies. She said the playground would be ADA compliant and be inclusive to all children no matter of their abilities. C. Kenney thanked D. Kelly and suggested the conversation be staved until the next workshop meeting. S. Harris agreed and commended D. Kelly and D. Garvansites, Park Manager, for their efforts.

ADJOURNMENT

As there was no further business before the Board, C. Bult made a motion to adjourn the 06/14/18 Town Board meeting at 7:47 p.m., seconded by C. Kenney. Meeting adjourned.
