Deputy Supervisor Bult called the July 12, 2018 Town Meeting to order at 7:01 p.m. with the Pledge of Allegiance and dispensed with roll call. All members present as stated above.

Executive Session

C. Swartz made a motion at 7:02 p.m. to enter into an Executive Session of the board pursuant to public officers law 105(f) to discuss matters leading to the appointment of a particular person or persons. Seconded by C. Kenney.

D.S. Bult chose to digress from the agenda to allow for a brief presentation by Steve Hart of Hart Engineering regarding resolution 2018-184 setting a public hearing for a proposed solar farm. Mr. Hart explained that he had submitted an application to the Planning Board regarding construction of the Pheasant Hollow Solar Farm off of Phillips Road in the Town of Schodack. Upon review of the application, the Planning Board gave a favorable decision and referred the application to the town board to set a public hearing for August 9, 2018. He noted the farm would be located on the west side of Phillips Road adjacent to the powerlines in area that requires a zoning changed to PD-2 for installation. It would be located by the town line for East Greenbush and Schodack; however, all structures would be located in Schodack. The design would consist of solar panels oriented in rows running parallel to the road to prevent any reflection that could be distracting to traffic. The array, consisting of eleven foot structures, would be surrounded by an eight foot fence with twenty six to seven foot evergreen trees and would be located approximately 630 feet from the

road. C. Rex asked if the documents Mr. Hart was presenting were available online or could be emailed to the board. Mr. Hart said information has been submitted to the Planning Board but he would be willing to email them as well.

Briefing of Resolution Agenda

D.S. Bult gave a brief overview of the resolutions. He said a 211 waiver was necessary for resolution 2018-182 for Chief Belardo for the purpose of his pension. With regard to resolution 2018-183, an easement is needed for the installation of the pump station for sewer district 1, extension 1. He noted resolution 2018-185 was an annual mass assembly permit application for Goold Orchards to hold their Apple Festival in the fall. Resolution 2018-187 was amended to include the following names: Bobby Sue Garvansite, Daniel Albertine and Kyle Loeper. In regards to resolution 2018-188, D.S. Bult advised that the cost of the heating pump did not include the cost for the electrical hook-up. For resolution 2018-189, the town was able to forego the presentation due to the town's status for the Section 8 Voucher Program. Resolution 2018-190 would amend a previous resolution to change the date of the heating from August 9th to September 13th to comply with the sixty day requirement as set by law. All other resolutions were self-explanatory.

Board Comment: None.

Public Comment

M. Sherwood asked why the officers for resolution 2018-187 were being classified as parttime. D.S. Bult explained the individuals needed to be sworn officers to attend the academy and since it is an uncompensated position and no cost to the town, it was decided to classify them as part-time officers. Atty. Mullahy said it was simply a formality and noted they would not be receiving a salary or benefits from the town. A resident of Van Hoesen Road asked, in regard to the proposed Amazon Distribution Center, why an Environmental Impact Statement (EIS) was not being completed. He noted a similar project was being conducted in Montgomery County and they were requiring an EIS be completed. Atty. Mullahy stated the public comment during a board meeting was generally only for comments and did not generally include answers from the board. He noted that the question would be better suited to be directed to the planning board as they were responsible for reviewing and approving the application. The resident asked when the public hearing had been set for. Atty. Mullahy said it was scheduled for June 18th and had been properly published and noticed by law. He made a point of clarification that the town board was not involved in the approval of the project.

Departmental Reports: The following monthly departmental reports were read and/or posted and filed in the Office of the Town Clerk: Historian, Town Clerk, and Building Department.

Review of Abstracts of Claims and Budget Amendments: The Board reviewed claims #18-1004 to #18-1175 on Abstract No. 2018-07 in the amount of \$820,000.42, including the claims paid prior (\$83,887.06).

Discussion Item

Recycling: B. Goodall explained that as of last year, the town was being paid for recyclables under the Albany County contract. As of January, the town was not being charged, nor were they being paid for recyclables. As of a few weeks ago, the town is now being charged \$120.00 per ton due to the Albany County contract ending. He mentioned an option would be to revert back to a sorting system for the recycling as cardboard, paper and cans were no charge but glass and plastic is \$120.00 per ton. This would increase labor costs, increase the number of runs and the public would need to be retrained. To date, 132 tons of recyclables have been brought to the Colonie landfill and if the trend continues, it could cost the town upwards of \$40,000.00 for recycling annually. He noted that had been told by a few residents that local garbage collection companies were currently charging users to collect recyclables and expressed concern that residents would begin to use the transfer station to deposit their recyclables to avoid the charge. D.S. Bult said he did not feel there was enough space at the transfer station to revert back to separating the recycling. He suggested Mr. Goodall review other options and recommended the issue be revisited at a workshop meeting. C. Kenney agreed and recommended they continue normal operations for recycling until it can be discussed at a later date. B. Goodall said he would need to increase his budget to accommodate for the increased costs. C. Swartz advised that they were not sure if this would be a long term or short term situation. D.S. Bult recommended Mr. Goodall increase his budget to factor in the cost for next year.

ADJOURNMENT

As there was no further business before the Board, C. Kenney made a motion to adjourn the 07/12/18 Town Board meeting at 7:42 p.m., seconded by C. Swartz. Meeting adjourned.
