Supervisor Harris called the March 14, 2019 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Briefing on Agenda

S. Harris gave a brief summary of the resolutions. He explained that an additional expense had been encountered during the remediation of the fuel spill at the Highway Garage (2019-111). He noted resolutions 2019-112 to 2019-117 pertained to the public hearings that were scheduled to take place at 7:10 and 7:20 pm respectively and would be explained by Atty. Ryan. For resolution 2019-118, the Supervisor stated an additional week had been requested for the music in the park event, hosting a total of five bands. He added that four bands had been turned away; however, they would be considered for next year. With respect to resolution 2019-127, the Supervisor said Attorney Craig Crist was acting as the temporary attorney for the Zoning Board of Appeals (ZBA) and would now be named the permanent attorney for the year. For resolution 2019-129, the Supervisor said, based on the new regulations set forth by the Governor regarding early voting, the second floor of the town hall would be prime for the county location due to the handicap accessibility and available space. All other resolutions were self-explanatory.

S. Harris welcomed the students who were attending the meeting for their Participation in Government class at Columbia High School. He wished them the best of luck in their future endeavors.

S. Harris informed the board that he had consulted counsel regarding donating a surplus roll-off dumpster from the transfer station. He explained he had spoken to the local fire chiefs, who expressed interest in the dumpster which could be converted into a smoke

house for training purposes. The dumpster would be centrally located at the South Schodack Fire House and the disposal of the unit would be at their discretion.

Public Hearing Proposed Local Law 2-2019

C. Bult made a motion to open the public hearing for proposed local law 2-2019 at 7:10 p.m. The motion was seconded by S. Harris.

The Town Clerk summarized the Affidavit of Publication seeking public comment on proposed Local Law No. 2 of 2019 (P2-2019) to amend Chapter 174, Article XI, Cost Allocation and Billing Provisions, of the Town of Schodack Code. The legal notice was posted on the Town Clerk's signboard, the Town's website and published in local newspaper, *The Record*, on March 4, 2019.

S. Harris asked Atty. Ryan to lead the public hearing. Atty. Ryan explained local law 2-2019 would amend chapter 174, article XI, regarding cost allocation and billing provisions, allowing the town board to annually review the two forms of allocation costs for each sewer district. Those costs include capital charges which are charged to each parcel of real property based on their assessed value and Operations and Maintenance (O&M) which are based on usage determined by units. By the board reviewing annually, it would allow for community input. He noted the chapter also dealt with the unit schedules, defined vacant properties and other general billing procedures.

Public Comment: M. Sherwood asked for clarification regarding the department referenced in §174-68(A,B,C,E,F). Atty. Ryan said the department had been defined earlier in the town code and was referring to the Building Department. Ms. Sherwood suggested an amendment be made as it was not clear. Atty. Ryan said the point was well taken; however, he felt an amendment was not necessary.

Hearing no further public or board comment, S. Harris made a motion to close the public hearing at 7:16 p.m. The motion was seconded by C. Bult.

Public Hearing Proposed Local Law 3-2019

C. Bult made a motion to open the public hearing for proposed local law 3-2019 at 7:22 p.m. The motion was seconded by S. Harris.

The Town Clerk summarized the Affidavit of Publication seeking public comment on proposed Local Law No. 3 of 2019 (P3-2019) to amend Chapter 176, Article XIII, Sewer Rents, of the Town of Schodack Code. The legal notice was posted on the Town Clerk's signboard, the Town's website and published in local newspaper, *The Record*, on March 4, 2019.

S. Harris asked Atty. Ryan to lead the public hearing. Atty. Ryan stated proposed local law 3-2019 would amend chapter 176 of the town code allowing for a more streamline process for the annual review by the town board of the Equivalent Dwelling Units (EDUs). He explained that the sewer use expenses were similar to those in chapter 174. The capital charges are defined as annual charges to cover any debt incurred by the district. The charges are determined based on the cost for infrastructure which is divided by all properties within the district. The operations and maintenance (O&M) rates are charged to any users within the district. He added, under §176-4, the town board must hold an annual public hearing to allow real property owners the opportunity to comment on the capital charges and O&M rates. Under §176-5, it is defined how the O&M rates are charged, when the capital charges go into effect and the number of EDUs. He noted that proposed local law 3-2019 is consistent with the current law of New York State.

Hearing no public or board comment, S. Harris made a motion to close the public hearing at 7:28 p.m. The motion was seconded by C. Rex.

Atty. Ryan explained that Laura Palmer, Supervisor Harris and he had been working for over eight to twelve months to refine the EDU schedule for sewer districts. He said negotiations were made with the Village of Castleton regarding the intermunicipal agreement for the transmission of effluent to the Village wastewater treatment facility. The negotiations helped to create consistent EDUs, which will also be adopted by the Village. He noted the EDUs now follow the proper class codes and by having a public hearing annually to set the EDUs, the public is protected and maintains transparency.

S. Harris thanked Atty. Ryan for his hard work and noted the town was lucky to have the best attorney in water and sewer litigation. Atty. Ryan recommended addressing resolution 2019-128 prior to his departure. He explained the revised Intermunicipal Agreement with the Village of Castleton updated the document, which had two prior iterations, and removed old wording such as "right of first refusal" regarding the purchase of wastewater refusal plants that no longer applied. He added the agreement would apply to sewer districts 1, 2, 4 and 7 which send effluent to the Village.

Public Comment (Resolution 2019-128): K. Koffman of Burden Lake Road asked if all the effluent from other sewer districts within the town was sent to the Village. Atty. Ryan said not all, as some are sent to other facilities based on their location. Ms. Koffman said, based on the wordage of the agreement, it seemed that it may be the plan of the town to create additional sewer districts within the town. Atty. Ryan explained the language was designed for any future districts that utilize the Village of Castleton Sewage Plant only. Ms. Koffman said the wording was unclear and suggested amending section 1(2) of the agreement. Atty. Ryan said he would be amenable to add the following wording: "utilizing the Village's waste water pollution control plant". All board members agreed. Ms. Koffman asked how the public was notified when a sewer district was created or extended. Atty. Ryan said according to Article 12 and 12-A of Town Law of the State of New York, public notice for a water or sewer hearing must be published in the local newspaper and on the town clerk's signboard not less than ten and not more than twenty days prior to the hearing. He added, even though not required, the notice is also posted on the town's website. In the event the town board felt the need to create a water or sewer district, the decision would be left to permissive referendum allowing the property owners within that district to vote to approve or deny the district. Ms. Koffman asked the difference between Article 12 and 12-A. Atty. Ryan explained under Article 12, the property owners within the district would petition for the creating of the district or extension based upon a map, plan and report. Under article 12, there would be no need for a permissive referendum. Under Article 12-A, the town board would start the process and a vote would be required amongst the owners within the district or extension.
