Supervisor Harris called the January 9, 2020 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

#### Executive Session

C. Swartz made a motion at 7:00 p.m. to enter into an Executive Session of the board to discuss the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation. Seconded by C. Rex.

#### Public Hearing Season's East Landscaping LLC Landfill Application

S. Harris called the public hearing on a landfill application submitted by Season's East Landscaping LLC to order at 7:34 p.m.

The Town Clerk summarized the Affidavit of Publication seeking public comment on an application submitted by Season's East Landscaping LLC to operate a clean landfill disposal on Route 9 pursuant to §137 of Town Code of the Town of Schodack. The legal notice was posted on the Town Clerk's signboard, the Town's website and published in *The Record* on December 30, 2019.

Steve Hart of Hart Engineering spoke on behalf of Mr. McGrath, the owner of Season's East Landscaping LLC. Mr. Hart explained the proposed eleven acre site was located south of Duck Pond Road, along the Thruway. He noted a stream ran through the site and it was the desire of Mr. McGrath to cut and fill the site from the stream forward encompassing 3.75 acres. The fill would be certified as clean with the site being covered by top soil and seed once finished. He added that upon the recommendation of Laberge and the Schodack Planning Board, a full Stormwater Pollution Prevention Plan (SWPPP) would be completed.

**Board Comment:** C. Swartz asked if any wetlands were discovered on the site. Mr. Hart said yes, along the stream. He added that all sites had been delineated by NYSDEC. C. Swartz asked what type of clean fill would be deposited. Mr. Hart explained the fill would consist of dirt and silt. It would not contain pieces of concrete or stumps and would be considered "clean" under NYSDEC regulations. C. Bult asked how many cubic yards of material would be deposited. Mr. Hart said approximately 5,000 cubic yards. S. Harris said it was his observation that the site was fairly level and flat. Mr. Hart said the site actually had a gradual slope of four to five feet below road level.

**Public Comment:** K. Stokem stated this was the fifth clean landfill application brought before the town board in the last year without any changes being made to the town code. He noted that he had presented concerns regarding Chapter 137 of the town code and asked when an update would be completed. S. Harris said they were still working on amending the code. Mr. Stokem asked if the town board was relying on NYSDEC regulations for these clean fill sites. Atty. Langlois explained that Chapter 137 of the town code was amended, the town board was obligated to follow procedures as set forth in chapter 137 to hold a public hearing and approve or deny any application for a clean landfill site. K. Stokem felt a change to the code should be seen as a priority before any other applications were accepted. T. Kirby asked if all NYSDEC standards were followed for clean fill sites.

S. Harris noted that the application would be referred back to the Planning Board for their recommendations.

Hearing no further comments, C. Bult made a motion to close the public hearing at 7:43 p.m. Seconded by S. Harris. All members agreed.

#### Brief of Resolutions

S. Harris gave a brief overview of the resolutions. He noted that resolution 2020-078 would be withdrawn at that time as further discussion was needed. For resolution 2020-080, he said an appeal had been received for an article 78 filed against the town creating a need to increase the dollar amount from previous resolutions to defend against the motion. With regard to resolution 2020-083, S. Harris said a copy of the resolution would be forwarded to Governor and other leaders who represent the Town of Schodack. All other resolutions were self-explanatory.

#### Public Comment (Resolutions)

**Resolution 2020-042:** M. Brunner asked if the vacant seat on the Planning Board had been posted or was the individual simply appointed. S. Harris said resumes had been received and were reviewed when selecting the candidate. M. Brunner said she knew the candidate owns her business and asked what would happen if an application for that business came before the Planning Board. S. Harris said she would separate herself from any involvement. K. Stokem also asked if the vacant seat had been publicized. S. Harris said it was known that the seat had become vacant with the passing of a member last year. K. Stokem said with the position not being posted, not all residents would aware of the opening. S. Harris said all residents were free to submit a resume to be kept on file to be reviewed in the event of a vacancy. K. Stokem said the process for selecting a candidate should be open to all residents. C. Rex agreed.

**Resolutions 2020-054 & 2020-055:** K. Stokem asked what role the attorneys played in the town. S. Harris said Tabner, Ryan and Keniry LLP represent the town for water and sewer matters and the Vincelette Law Firm represents the town on assessment grievances.

**Resolution 2020-062:** K. Stokem asked why the Advertiser could not be designated as the Town newspaper. The Town Clerk said that by law, the official newspaper must be one subscribed to and as the Advertiser is a free periodical, it could not be used. She noted that legislation was proposed last year to allow for free newspapers to be included; however, it was not passed.

**Resolution 2020-065:** K. Stokem asked why a contract with Schodack Valley Fire District was not included. C. Bult explained the districts listed were known as protection districts that cover areas not designated in other fire districts. He added that the contracts set rates for tax payers in those areas.

**Resolution 2020-071:** K. Stokem asked if the town tracks the amount spent annually for engineering costs. P. Harter said yes and noted that the amounts could be requested at any time.

**Resolution 2020-077:** K. Stokem asked where along Route 9 the site would be located. S. Harris said it would be easiest for Mr. Stokem to come to the town hall and he would show him in the map. C. Swartz mentioned the location was nearest to Kids Lane. K. Stokem asked if an applicant was required to supply a map of the site when applying. S. Harris said yes.

**Resolution 2020-079:** K. Stokem asked why a temporary accountant was necessary. J. Bult said the comptroller's office was short staffed and this firm was backfilling a position.

**Resolution 2020-080:** K. Stokem asked if the \$25,000.00 was the maximum that had been spent for litigation regarding the article 78. Atty. Langlois said this only related to the appeal. Mr. Stokem asked what the prior approved amount for the article 78 was. Atty.

Langlois said he was not certain of the amount. P. Harter informed Mr. Stokem that he could contact the Comptroller's Office and he would give him the amount.
