Direct the Town Assessor, pursuant to the authority conferred by Executive Order No. 11.1 issued by the Governor on December 26, 2021, to grant real property tax law exemptions pursuant to Real Property Tax Law Sections 459-c and 467 on the 2022 assessment roll to all property owners who received such exemption(s) on the 2021 assessment roll, thereby dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for the Town Assessor to mail renewal applications to such persons, provided, however, that the Town Assessor may require a renewal application to be filed when the Town Assessor has reason to believe that an owner who qualified for such exemption(s) on the 2021 assessment roll may have since changed his or her primary residence, added another owner to the deed, transferred the property to a new owners, or died.
