Supervisor Peter called the January 11, 2024 Town Board Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

#### **Zoning Update**

N. Allen of the Laberge Group explained that it had taken a few years but the zoning code amendments appeared to be complete, allowing the board to proceed with the review process. Said amendments incorporated elements from the town center plan, definitions and clarified language to adapt to the town needs. She noted that the General Environmental Impact Statement (GEIS) that had been completed for Route 9 by Rensselaer County included a list of uses and a findings statement that could be included in the amendments or adapted based upon the wishes of the town board. S. Peter advised that the board would review certain topics within the code at each workshop meeting, addressing any concerns or additions (including any necessary updates needed for the growth of Route 9). Once completed, a public hearing will be scheduled to adopt the newly amended zoning code.

#### **Brief of Resolutions**

S. Peter summarized all resolutions on the agenda. All resolutions were self-explanatory.

**Board Comment (Resolutions):** C. Swartz said a discussion had occurred during the budget workshops regarding depositing cash at KeyBank to minimize bank runs. He asked why KeyBank had not been included as a depository for the town (2024-04). P. Harter noted that the town had moved from KeyBank due to their exorbitant fees and cautioned against utilizing them. C. Swartz requested that they be contacted to determine the feasibility and cost of fees for the deposits as he felt the trips to the bank by each department were excessive.
