### Open Discussion

**Summer Events:** S. Peter mentioned that the Easter Egg Hunt has been scheduled for March 16<sup>th</sup> with an inclement weather date of March 23<sup>rd</sup>. He said he was working to schedule other events and would announce them in the coming months.

**Meeting with Laberge Group:** S. Peter informed the board that he would be meeting with R. Laberge regarding various projects including the feasibility study for a splash pad, code updates, a future infrastructure project and meeting with Rensselaer County Officials regarding the Route 9 Water South project. He added that the county would be paying for the project with American Rescue Plan Act (ARPA) funds; however, the town was coordinating said project. He welcomed a board member to be present at the meeting.

**Zoning Code:** S. Peter said he had spoken to N. Allen of the Laberge Group regarding sections of the zoning code that needed to be addressed. He added that the solar battery moratorium would be ending and the board would be moving forward with a public hearing for the proposed local law.

### **Public Comment**

M. Ruthman of the Spinney Group reminded the board about the crosswalk that had been discussed for the Spinney residents to access the clubhouse and asked about the status. B. Brahm, Highway Superintendent, said he had spoken to two companies in the fall regarding

pricing for the striping; however, the weather grew too cold. He assured Mr. Ruthman that it was scheduled to be done in the spring of 2024. Mr. Ruthman appreciated the update and wished to also remind the board that it had been three years since the proposed Van Hoesen Station had been submitted to the Planning Board. He understood that the zoning code needed to be completed but he wanted to keep the lines of communication open as he felt the project, which included apartments, would be beneficial to the town.
