Supervisor Dowds called the March 13, 2014 meeting to order at 6:01 p.m. with the Pledge of Allegiance and dispensed with roll call. All present as noted above.

Executive Session

C. Curtis made a motion at 6:03 p.m. to enter an Executive Session to discuss potential water/sewer contract negotiations. Seconded by C. Bult.

Public Hearing

Consolidated Water District No. 101- Extension 3

S. Dowds opened the public hearing for Extension 3 of Consolidated Water District No. 101 at 7:15 p.m.

The Town Clerk read an abstract of the affidavit of publication seeking public input on Extension No. 3 to Consolidated Water District No. 101 (CSW-101), pursuant to Article 12A of New York State Town Law. The legal notice was published in the February 24, 2014 edition of "*The Record*" and posted on the Town Clerk's signboard on February 24, 2014. Said notice was also posted on the Town's website, www.schodack.org.

William Ryan, Special District's Counsel, stated that a Map, Plan and Report has been filed regarding this extension and called upon Richard Laberge, Laberge Engineering, to highlight the report.

Mr. Laberge explained that last year the town expressed interest in extending the district to include various parcels on Inglewood Road, Timber Ledge, Waters Road and Old Miller Road, for a total number of 15 parcels. It is anticipated that the parcels would use approximately 3,000 gallons of water a day which is within the capacity of the existing system. He continued that if the extension is approved, there are several regulatory items that need to be addressed such as the water supply application from DEC and a sign-off from SHIPO. He noted that the town was not extending water mains for this extension as they already exist, so they are essentially being added into the district without construction. The anticipated \$8,500.00 project cost is related to engineering, legal, and water department and administration expenses for the district formation. Since all the homes are single family residential, each will be assigned one (1) capital unit annually for the debt service. That cost for 2014 will be \$330.00 but that capital charge may fluctuate from year to year. With regard to Operation and Maintenance charges (O & M) for water use, the current water use rate is \$4.00/1,000 gallons with a minimum quarterly charge of \$75.00 for up to 18,000 gallons for an annual estimated cost of \$300.00. Since most single family homes fall within the minimum charge, the annual estimated costs for 2014 will be \$630.00. In closing, Mr. Laberge noted that upon connection, the Town will be waiving the hook-up fee; however, there will be a one-time administrative fee of \$225, a building permit fee of \$50.00, a meter fee of \$250.00 and the initial inspection fee of \$25.00/meter.

Atty. Ryan added that under Article 12A of Town Law, the Town has to post and publish legal notice of the public hearing, no less than 10 nor more than 20 days from the scheduled date, which was done. All the property and property owners will be benefitted from this extension.

Public Comment

Geri Pomerantz, who lives in the proposed district extension (Waters Rd.), said that the Assistant Comptroller has been very helpful answering some of her questions. She said she did not object to the water district extension, or having the lines on her property, but she said she is not going to connect because she has a good well. Therefore, she feels this is a tax. She said that, essentially, the existing homeowners are being required to subsidize the cost of bringing water to the people who will be getting the water, which are primarily new construction folks and she didn't think that was very fair. It was her opinion that she will not get any benefit from this extension, especially when it comes with a \$400.00 + cost which she believes will make it harder to sell her property. She said she could understand if the Board wanted to assess a token charge to the property owners who won't be using it, but not \$330 - \$400.00 annually.

Jean Wilson asked if the Love Lutheran Church property was in the district. The Supervisor said yes. Mrs. Wilson said she was confused as to whether they are served by Schodack or East Greenbush. The Supervisor said the church gets water from the Town of Schodack and they have a contractual agreement with the Town of East Greenbush for sewer.

Jonathon Cohn, who lives in the proposed district extension (Old Miller Rd.), asked if everyone in the district will pay the same capital charge of \$330.00 for 2014. Mr. Laberge said yes that is the capital unit charge. Some people are assessed more capital units if they

have multi-family housing, commercial, etc. Mr. Cohn asked if some people pay less than \$330.00. The Comptroller said there is a variety of property classifications that range from 1/4 of a unit to 3/4 of a unit, such as vacant land which is assessed at a 1/2 unit. Mr. Cohn agreed with much of what Ms. Pomerantz said and felt that an assessment for a vacant parcel should be analogous to someone in the district who isn't connected to the system. Atty. Ryan explained that annually the town board reviews the methodology for assessing the unit charges and over the course of time one unit was adopted for the typical single family residence. He suggested that he go to the town web site and look at the resolution that adopted the unit charges, which he believed occurred in November. Mr. Cohn said he found that the cost to bring water from the curbstop to the home is thousands of dollars so while it may look like a fairly nominal fee, the costs for the homeowners to actually get access to the water is very costly. The Supervisor said that the charges discussed were the town's fees: the cost to bring the water from the main to the home is a private fee. Mr. Cohn said he said was not necessarily disagreeing with a fee for having access to water, but felt there should be a lower cost for someone who simply has access, but is not connected, like abandoned property. Atty. Ryan clarified that the unit structure does not deal with abandoned houses, the lower unit charge mentioned is for vacant land.

As all persons wishing to be heard, were heard, upon motion by C. Kenney, which was seconded by C. Curtis, the Supervisor closed the public hearing at 7:31 p.m.

WHEREAS, said project will require compliance with the provisions of the Environmental Conservation Law of the State of New York and regulations of the Department of Environmental Conservation, Part 617, State Environmental Quality Review Act and the Town of Schodack has established that the Town Board act as lead agency for the review of plans and environmental impact, if any, of the proposed establishment of Schodack Consolidated Water District No. 101, Ext. No. 3.

NOW, THEREFORE, The Town Board of the Town of Schodack as lead agency has determined that the establishment of Consolidated Water District No. 101, Ext. No. 3 will not result in any significant adverse environmental impacts, and that the Supervisor of the Town of Schodack be authorized to execute any documentation with respect to the determination that the establishment of Consolidated Water District No. 101, Ext. No. 3, is a Type II action and that the establishment of Consolidated Water District No. 101, Ext. No. 3 will not result in any significant adverse environmental impacts.

WHEREAS, the order set March 13, 2014 at 7 p.m. at the Schodack Town Hall, 265 Schuurman Road, Castleton, New York as the date, time and place of the public hearing to consider the map, plan and report, and to hear all persons interested in the subject, and to take action as required and authorized by law; and

WHEREAS, such order was published and posted as required by law; and

WHEREAS, a hearing on the matter was held by the Town Board on the 13th day of March, 2014, beginning at 7 p.m. and the matter being duly discussed and all interested persons having been duly heard;

NOW, upon the evidence given at the hearing,

RESOLVED AND DETERMINED:

- (a) That the notice of hearing was published and posted as required by law, and it is otherwise sufficient;
- (b) That all property and property owners within the proposed water district extension are benefited thereby;
- (c) That all property and property owners benefited are included within the limits of the proposed water district extension;
- (d) That it is in the public interest to establish Town of Schodack Consolidated Water District No. 101, Ext. No. 3;
- (e) That the maximum amount proposed to be expended for said improvements and/or the acquisition of necessary lands is Eight Thousand Five Hundred Dollars (\$8,500.00) and that the first year cost of full operation for typical properties within Consolidated Water District 101, Ext. No. 3 shall equal Three Hundred Thirty (\$330.00) Dollars for debt service and Three Hundred (\$300.00) Dollars for water use with the charges to vary in relation to the amount of benefits provided;
- (f) That the approval of the New York State Comptroller is not required for the creation of Town of Schodack Consolidated Water District No. 101, Ext. No. 3; and it is

FURTHER RESOLVED AND DETERMINED, that the establishment of Consolidated Water District No. 101, Ext. No. 3 as set forth in the map, plan and report, be approved and that the requested improvements be constructed, and the necessary easements be obtained, and it is

FURTHER RESOLVED AND DETERMINED, that this resolution shall be subject to a permissive referendum in the manner provided in Article Seven of the Town Law.

Briefing of the Remaining Resolutions

With respect to resolution [2014-100], he noted that the Board was very pleased to have the Yankee Doodle Band for the 4th of July week. C. Kenney added that if people haven't seen them they should take advantage of this wonderful opportunity. Normally, their fee is over \$2400.00 so the board felt very fortunate in getting them for that price. All other resolutions are self-explanatory.

Public Comment

R. Lemka asked the status of the zoning code update, and if it was known when it would be introduced to the public for comment. Mr. Laberge stated that it was authorized last year and a small committee was formed consisting essentially of staff. They were charged with analyzing the Code and identifying the issues. He said between vacations, holidays and personal schedules, it has been a slow process getting them together, but they did meet recently to work on a memo outlining priority areas for revision, which they hope to complete within 6 weeks. Once it's done, they will forward it to the Town Board for their review, input and further direction. At that point they hope a more definitive schedule will be established.
