Supervisor Dowds called the July 13, 2017 Town Meeting to order at 7:00 p.m. with the Pledge of Allegiance and dispensed with roll call. All members present as stated above.

Executive Session

C. Swartz made a motion at 7:01 p.m. to enter into Executive Session to discuss specific appointments for Building inspector and Assistant Assessor. Seconded by C. Rex.

Adoption of Resolutions

Upon receiving the majority vote, the Supervisor asked Mr. Tremblay to come to the dais. Mr. Tremblay thanked the Board and stated that he appreciated the opportunity to work for the town.

Briefing of Resolution Agenda

The Supervisor gave a brief overview of the remaining resolutions. He stated that the proclamation for resolution [2017-177] had been read and presented to Donna Conlin, retired Town Clerk on her last day of work June 30, 2017. Resolution [2017-178] would amend the previous resolution to approve substitute counselors for the Schodack Day Camp. In regards to [2017-179], the regularly scheduled meetings for July 27, 2017 and August 24, 2017 would be cancelled. Additionally a special meeting would be scheduled for July 20, 217 to begin between 5 and 6 p.m. Resolutions [2017-180 to 2017-183] authorize the following departments to attend training: Justice Court, Police and Assessor. Resolution [2017-185] had been withdrawn because the funds had been accounted for in a resolution set forth earlier in the year. The remaining resolutions are self-explanatory.

Board Discussion

Regarding resolution [2017-182], C. Swartz asked how many Tasers had been previously purchased and why an additional instructor was needed. S. Dowds explained three had been purchased. By having Office Roehr Jr. attend training, the Town would have two certified instructors for future training. C. Bult inquired if the Tasers were currently in use. S. Dowds said yes and added that training had been completed.

Public Comment

C. Peter took exception to how a few Board members voted regarding the appointment of Debra Curtis as Town Clerk. He explained that the Town Clerk is the face of the Town Hall and to not fill the position promptly would be doing a disservice to the residents. He felt that Ms. Curtis would be a great asset to the Town and also thanked Donna Conlin for her years of service.

M. Sherwood mentioned that she noticed mowing had been done at the old Drumm Property. She asked if there had been any ideas for use of the property. S. Dowds said not as of yet. She continued by mentioning that recently, the Town encountered a power outage and the traffic light at the Route 9&20 and Route 150 intersection was not working. She said that a Schodack Police Officer was sitting on the side of the road with his light flashing but was making no effort to direct traffic. C. Bult stated that our officers are trained to serve as a presence to slow traffic down if they do not have adequate staffing to manage the intersection. M. Sherwood asked why the fire department was not called in. C. Bult explained that they were called in and added that in the past, we have requested assistance from DOT but have been denied.
